### **Web Access to Your OCLC Billing Statements Coming Soon!**

MINITEX Administrative and Financial Services (AFS) rolled out TravWEB in December. TravWEB is new software that will enable MINITEX participating libraries to access their financial data via the web through a server available at the MINITEX Office. The roll out of accounts began with the MINITEX deposit account holders, and it is planned that the balance of libraries will follow soon thereafter.

TravWEB will allow participating library staff to see their institution's account balances, open invoices and statements, and OCLC monthly billing detail as well as invoice, payment, and product history. Libraries will be able to drill down and reprint invoices and statements as needed.

Letters are being prepared for Library directors that include URL instructions, account ID's, and passwords. MINITEX will be providing a training schedule after the holidays. ### **OCLC Releases International Library Research Report**

OCLC has found that information consumers view libraries as places to borrow print books, but they are unaware of the rich electronic content they can access through libraries. The findings are part of *Perceptions of Libraries and Information Resources*, a report issued in December, 2005 by OCLC. The new report, based on surveys of information users across six countries administered by Harris Interactive on behalf of OCLC, is a follow-up to *The 2003 OCLC Environmental Scan: Pattern Recognition*, the award-winning report that describes issues and trends that are impacting and will impact OCLC and libraries.

Among the findings of the new report:

- Respondents use search engines to begin an information search (84 percent). One percent begin an information search on a library Web site.
- Information consumers use the library but they use the library less and read less since they began using the Internet.
- Borrowing print books is the library service used most; "Books" is the library brand.
- Quality and quantity of information are top determinants of a satisfactory electronic information search, not speed of results.

- Respondents do not trust purchased information more than free information.
- Ninety percent of respondents are satisfied with their most recent search for information using a search engine.
- Information consumers like to self-serve. They use personal knowledge and common sense to judge if electronic information is trustworthy, and they cross-reference other sites to validate their findings.
- The survey results show that library and information preferences and use are consistent among respondents in the six countries surveyed.

### **OCLC Publishes 38th Annual Report to the Membership**

In the annual report, Jay Jordan, OCLC President and Chief Executive Officer, wrote that fiscal 2005 was "an eventful year—one of continuing innovation and steady growth. Libraries completed their migration to our new technological platform, and we began offering new services and programs on that platform. WorldCat grew faster than in any previous year since it began operation in 1971. Moreover, cooperation in our global network continued to increase with new forms and new partners."

Thirteen libraries and organizations are featured in the report, which has been mailed to OCLC member libraries, regional service providers, and global service providers. In the back of the report is a timeline that traces significant events in OCLC's history from 1971 to 2005.

### MULS Union List Training

As Feb. 19, 2006 (the date for migration of OCLC's Union List functionality) approaches, many library staff are interested in receiving training on the new tools for maintaining local holdings information (or Local Holdings Records, LHRs). MINITEX MULS unit staff is busy working to ensure we have training materials and guides ready for MULS users in time for the migration.

One difficulty we face in creating training is that OCLC cannot provide a prototype or test version of the Connexion Browser interface for Local Holdings Records maintenance that we can use to test or demonstrate the system's functionality prior to migration. There are tutorials and supporting documentation about the Connexion Browser available, and that is certainly a good place to start. But, some aspects of training will benefit from waiting until after migration, so trainees can actually try the systems out.

Currently, our plan is to create and present the following training:

**MULS Migration:** an overview of the migration and what we expect to change in the Connexion Browser environment. These **webinars** have been scheduled in January and early February. To register, see the following URL:

The session will be archived so library staff who cannot attend a live session will be able to listen to the recorded version.

**Searching MULS in Connexion:** a look at searching via the Connexion Browser, focusing on how the search options help us locate Local Holdings Records information. These **webinars** will happen in February.

**MARC Format for Holdings Data (MFHD):** a look at the specifics of how OCLC is implementing the MARC21 Format for Holdings Data in the Connexion Browser. This session will provide staff with general guidelines and specific examples of holdings created in OCLC that utilize MFHD. These sessions are being planned for later in February and March, *after the migration* to Connexion.

**Editing Local Holdings:** an examination and practice using the Connexion tools to edit, delete, and create Local Holdings Records in OCLC. We will look at mechanics as well as workflow issues and discuss the possibilities for using constant data to make repetitive tasks simpler. These **webinars** will be presented in March and April.

**Updating MULS in Connexion:** These day-long, hands-on sessions will cover much of the same material as the Searching, MARC Format, and Editing Local Holdings webinars, but will be presented in-person and will provide opportunities for hands-on work with the Connexion Browser tools. Sessions are being planned for Minnesota, North Dakota, and South Dakota between mid-March and the end of May.

## December Enhancements for WorldCat Collection Analysis

On Dec. 11, OCLC released the following enhancements to the WorldCat Collection Analysis Service:

**A Holding Count Limit has been added to the WorldCat Comparison.** It allows users to limit the results of their analysis by how many libraries share items in their collection. For example, an analysis could be limited to items with specific publication dates owned by the library and one other institution. In this way, the user could more readily discover which items in the library's collection are rare enough to warrant special handling.

- To try this out, starting from the default Analysis Results screen, go to the "Data to Analyze" drop-down menu (on the right) and click on "WorldCat Comparison." Then, on the Comparison screen click on the "Limit Analysis" tab, choose from among the options, and run your analysis.

**Overlap information is now displayed with Uniqueness information in Individual Library Comparisons with Peers.** In other words, Overlap is no longer a separate option. OCLC made this change because the "Shared by 2" information on the Uniqueness tab already represented the Overlap information in a more meaningful way.

- From the default screen, go to the "Data to Analyze" drop-down menu and click on the name of a comparison group. When the group data is displayed, click on the Uniqueness tab. You will see columns for Uniqueness and Overlap.

**Also in Individual Library Comparisons, a Holding Count row dimension can now be displayed beneath the Library row dimension.** This feature shows how many libraries in a given comparison group own items. If a comparison group, for example, is created with 4 OCLC symbols, the Holding Count dimensions would be Held by 1, Held by 2, Held by 3, and Held by 4. The user can use a Holding Count Limit feature to limit analysis to items owned by one or two group members or as many as needed.

- From the default screen, go to the "Data to Analyze" drop-down menu and click on the name of a comparison group. When the group data is displayed, click on the name of the group (underlined on the left). The holdings rows will appear beneath the library row.
- To use the Holding Count Limit, go to "Limit Analysis," choose a Holding Count option, and click "Run Analysis." Then, click on the comparison group and the holding row you choose will appear beneath the library row.

## **Amazon.com Joins the Open WorldCat Program as Fulfillment Partner**

Amazon.com has joined Baker & Taylor as a fulfillment partner within the Open WorldCat program to facilitate the online purchase of books identified through WorldCat. Web searchers who reach WorldCat from popular search engines or other Web resources may now use a book-buying link to purchase books through Amazon.com, in addition to the initial pilot partner, Baker & Taylor.

This component of Open WorldCat not only connects Web searchers with the materials they need, it also delivers a financial benefit to all libraries that participate in the program. Each time a Web searcher purchases a book through Open WorldCat, a portion of the proceeds supports the ongoing development of Open WorldCat for the benefit of all participating libraries.

Web searchers reach the Open WorldCat interface from search results in Web search engines or popular Web resources. Users may link directly to Amazon.com from "Find in a Library" for some items. When a direct link is not available, users will have the option of linking to the Amazon.com site to search for similar items.

The new Connexion Client 1.50 lets you choose levels of validation, use a batch process to set or delete holdings, and pre-set start-up actions. This webinar will highlight these changes and other additions in 1.50, and help you decide whether to upgrade or stay on version 1.40 for a few more months.

- A drop-down list of material types for WorldCat searches
- Automatic application of constant data in batch processing
- Drop-down lists of fixed field values

- Resolutions of known problems in Connexion Client 1.40

## **Vendor Records in WorldCat**

Many of you have begun seeing records in WorldCat that are contributed by book vendors, and you might be wondering about the quality of these records. Also, 938 fields are now appearing in many records. What is that all about?

OCLC now has a vendor record contribution program. As stated on the Web site (<http://www.oclc.org/vendors/material/contribution/default.htm>), OCLC is pursuing working relationships with library material vendors and vendors of bibliographic records in order to enrich the WorldCat database. OCLC is especially interested in the contribution of records pertaining to non-U.S. materials and audiovisual materials.

As to the quality of these records, OCLC database specialists thoroughly evaluate records submitted by vendors. OCLC loads vendor records into WorldCat **only if** the following conditions apply:

- The records do not match existing records
- Fewer than 2% of the records contain machine-detectable errors in MARC coding
- Fewer than 20% of the records are duplicate records in WorldCat
- The records adhere to U.S. standards for cataloging, including both descriptive cataloging and forms of headings
- The records meet OCLC minimum (K-level) standards for completeness
- The records are in MARC 21 format

#### Library material vendors

- When a vendor record matches an existing WorldCat record, OCLC adds a vendor-specific 938 field to the master record.
- When no single unique match is found, OCLC adds the vendor record as a new record with a 938 field.
- In both cases, OCLC sets the vendor's OCLC symbol

#### Bibliographic record vendors

- A 938 field is not added
- No OCLC symbol is set

#### Explanation of the 938 field

The 938 field contains vendor specific ordering data. Some examples of 938 fields:

- Subfield #a: full name of vendor
- Subfield #b: OCLC-defined identifier for vendor. These identifiers are different from the OCLC institution symbols.
- Subfield #c: terms of availability (purchase price)
- Subfield #d: vendor net price
- Subfield #i: vendor inventory number. This may be an ISBN.
- Subfield #n: vendor control number. This is a unique number assigned by the vendor to identify the item for offline ordering.
- Subfield #s: vendor status. This indicates if the item is back ordered, out-of-print, not yet published, etc.
- Subfield #z: note. This is a general notes filed in which a vendor can include order information specific to the item.

To facilitate searching for vendor records in WorldCat, OCLC indexes field 938 subfields #a and #b.

### **Helpful Dewey Tool**

Could you use a little refreshing of your Dewey decimal classification knowledge? Or, maybe, you were never fully trained in the first place. Help is available in the form of a new (or rather revised) publication, *Dewey Decimal Classification: Principles and Application*, 3<sup>rd</sup> edition, by Lois Mai Chan and Joan S. Mitchell. This new edition, published in 2003, is a replacement for *DDC: A Practical Guide* (1996). It is a companion for DDC 22 and can serve as a helpful teaching tool that offers in-depth advice on applying the DDC and building class numbers. It also includes practice exercises to reinforce the text.

### **How Do I Add My OpenURL server to FirstSearch?**

The next page has the answer to question number 2 on OCLC's Top 10 Questions Asked about FirstSearch, "How do I add my OpenURL server to FirstSearch?" The following solution can also be found in the Help section of the FirstSearch administrative module:

Some libraries use OpenURL servers to help connect their users to available online resources. For example, a user retrieves a record in an online database that contains a description of a document. The user wants to view the full text of the document. The record contains a link that leads to an OpenURL server. The user clicks the link. The link sends information about the document to the server. The server displays a screen that contains links likely to lead to the document or more information about it.

The OpenURL Links feature in the FirstSearch administrative module lets libraries add links in FirstSearch databases that lead to their OpenURL servers.

Perform this task when you want to add a new OpenURL server for your library. Log in to the FirstSearch administrative module at:

Once logged on to the FirstSearch Administrative Module, perform the following procedure:

	Action	Result or Note
1	Click <b>OpenURL Links</b> in the sidebar menu of the <b>Resource Sharing</b> section of the main menu.	The system displays the <b>OpenURL Links</b> screen.
2	Type the URL for your library's OpenURL server in the <b>Add OpenURL Server</b> field.	
3	Accept the ISBN provided for testing access to your library's OpenURL server or type another ISBN in its place.	
4	Click the <b>Test</b> button.	The system displays a new browser window containing the screen that your OpenURL server displays for the test ISBN.
5	Close the new window. If the test is not successful: Verify that you have the correct URL for your library's OpenURL server. Repeat steps 2 through 4.	
6	If the test is successful, click the <b>Add Server</b> button.	The name of the server you added appears in the <b>Select OpenURL Server</b> field.
7	If you want to change the URL for the icon that FirstSearch displays as a link to the OpenURL server, type it in the <b>Add OpenURL Icon File</b> field.  If you want to change the link text that FirstSearch displays as a link to the OpenURL server, type it in the <b>Add OpenURL Link Text</b> field.	You must supply the icon file URL, link text, or both. The recommended image size of the icon is 16 pixels high and up to 64 pixels wide. If the image is more than 16 pixels high, FirstSearch scales its height to 16 pixels and scales its width proportionally.

	Action	Result or Note
8	Click the <b>Test</b> button located below the <b>Add OpenURL Icon File</b> field and/or the <b>Add OpenURL Link Text</b> field to test the appearance of the icon and/or the link text.	The system displays a new browser window with a sample link containing the icon and/or link text. The purpose of the sample is to show the appearance of the icon and/or link text. Neither link leads to the new OpenURL server.
9	Close the new window. If the test is not successful: Be sure that you have the correct URL for the icon file. Repeat steps 7 and 8.	
10	If the test is successful, click the <b>Add/Rename Icon File</b> button and/or the <b>Add/Rename Link Text</b> button, depending on whether you have added an icon file URL, link text, or both.	
11	In the <b>Databases Included</b> list, remove any databases in which you do not want the icon link or link text for your OpenURL server to appear. To remove a database: <ol style="list-style-type: none"> <li>1. Click the database in the <b>Databases Included</b> list.</li> <li>2. Click the <b>Remove</b> button.</li> </ol>	By default, the links appear in all of the databases included in your FirstSearch account.  To remove multiple adjacent databases simultaneously: <ol style="list-style-type: none"> <li>1. Hold down the &lt; <b>Shift</b> &gt; key.</li> <li>2. Click the first and last database you want to remove.</li> <li>3. Click the <b>Remove</b> button.</li> </ol> To remove multiple non-adjacent databases simultaneously: <ol style="list-style-type: none"> <li>1. Hold down the &lt; <b>Ctrl</b> &gt; key.</li> <li>2. The values that you can set for the Add OpenURL Server field are described in the following table.

Blank	No new OpenURL Server URL.
OpenURL Server URL	A URL for a new OpenURL server for your library.

**Note:** You may have a maximum of 10 OpenURL servers at one time. If you attempt to add a new OpenURL server without first adding an icon file URL or link text for the previously added OpenURL server, the system will pop up an alert telling you to add an icon file URL or link text or both, or delete the server you previously added.
