Connexion Client 1.40 Released

Connexion client version 1.40 is now available! Client 1.40 includes a spell check, offline validation, additional non-English interfaces, Hebrew, Greek, and Cyrillic script cataloging, access to the Chinese Name Authority File, and more! Collection Analysis: One-On-One Comparison

Recently, OCLC enhanced the WorldCat Collection Analysis (WCA) service to allow individual subscribers to create a comparison with just one other institution. Previously, if you subscribed to the service, you were able to view your own institution and compare it to a group of 2-5 libraries.

In order to use this new WCA feature, the requesting library must get written permission from the comparison library and provide proof of this permission to OCLC. To get permission, staff of the interested library should contact the appropriate staff at the potential comparison library. After obtaining permission from the potential comparison library, library staff would then need to email their permissions to:

wcapermission@oclc.org

There is a hyperlink to a permission letter template on the Collection Analysis tab in the FirstSearch Administrative module. The template includes example text for requesting permission to include an individual library's holdings in a one-to-one comparison. Subscribers can save this Word document, fill in the appropriate names and email it as an attachment to the comparing library, OR they can copy-and-paste it into an email. Macro of the Month: Moving Existing Data to a 949 MARC field

This month's macro takes the 090 (LC number) and the 049 (local holding code) information from a workform and pastes it into a 949 (local processing) MARC field. You can use this macro as a template, and modify it to fit your local needs. If you would like to try it out and have trouble, please contact us at the MINITEX BATS unit (contact information at the end of this *Mailing*). It may be easiest to copy the text from the electronic version of the *Mailing* and paste it into Connexion client. You can access the electronic version at this url:

'MacroName:090and049to949

'MacroDescription: Takes the 090 and 049 MARC field data and moves it to the 949

Sub Main

Dim CS As Object

Set CS = CreateObject("Connex.Client")

bool = CS.GetField("090", 1, CallNumber)

If bool = FALSE Then

MsgBox "Your record must contain an 090 field"

Exit Sub

End If

'Get the 049 tag and store in HoldingCode

CS.GetField "049", 1, HoldingCode

'Remove the tag number and indicators from the string leaving just the call number

Accessing and Viewing Connexion Statistics

Connexion Statistics are now available. Daily reports allow you to search by date and the number of days for the current month. Monthly reports will be available for 18 months.

You can sign up to receive reports on demand or on a schedule by email in HTML or as an Excel spreadsheet. The Excel spreadsheet allows you to manipulate the statistics locally.

There are two views for the reports: Usage Report, which summarizes the activity into broad categories, and All Activity, which shows all available statistics. Currently, the available statistics are:

- WorldCat Searches, Browsers, Replaces, and Exports
- Update Existing and New WorldCat Records
- Produce Existing and New WorldCat Records
- Display Holdings
- Delete Holdings
- Authority Searches, Browsers, Adds, Replaces, and Exports
- PICA Searches

OCLC will add additional statistics to the reports in the future. There are a few different ways to view your Connexion usage statistics:

- From the OCLC Usage Statistics Web page. Enter a valid authorization and password:
