The Commencement speaker, Irving Younger, is Samuel S. Leibowitz Professor of Trial Techniques at Cornell Law School. Professor Younger is recognized as one of the nation's outstanding experts in the field of trial practice and is in constant demand throughout the country as a lecturer in this area. He is a graduate of New York University School of Law, a former partner in a New York City law firm and a former Civil Court judge. Professor Younger is also a Regional Director of the National Institute of Trial Advocacy. His videotaped lectures on trial practice are used by virtually all law schools in the United States.
