JUSTICE HARRY A. BLACKMUN

Our Commencement speaker, Justice Harry A. Blackmun, is an associate justice of the United States Supreme Court. Justice Blackmun is a 1929 graduate of Harvard University, from which he also received his LL.B. in 1932. He became a member of the Minnesota bar in 1932, serving as a law clerk to Honorable John B. Sanborn, U.S. Circuit Court of Appeals for the 8th circuit. He joined the law firm of Dorsey, Colman, Barker, Scott & Barber in 1934 and remained there until 1950. He served as resident counsel to the Mayo Clinic in Rochester until 1959 when he was appointed as a judge for the U.S. Court of Appeals, 8th Circuit. He was appointed to the United States Supreme Court in 1970, where he presently serves. Justice Blackmun has been an active supporter of the University of Minnesota Law School, serving as an adjunct member of the law faculty in 1945-47. It is with great pleasure that the members of the University of Minnesota Law School Class of 1982 welcome Justice Blackmun as our speaker today.
