HONORABLE MILES W. LORD

Our Commencement speaker, Judge Miles W. Lord, received B.A. and LL.B. degrees from the University of Minnesota.

Judge Lord served in the Army Air Force Aviation Cadet Program, 1944-45; as Assistant U.S. Attorney, 1951-52; Attorney General for the State of Minnesota, 1954-60; and as United States Attorney, 1961-66. He was appointed United States District Judge for the District of Minnesota on April 28, 1966. He became Chief Judge of the District on May 1, 1981.

He is best known to the general public as presiding judge in the Reserve Mining pollution case and in the class action cases involving alleged monopolization and price-fixing in the sale of antibiotics.

In 1981 Judge Lord was honored as the Outstanding Federal Trial Judge in the nation by the 40,000 lawyers who are members of the Association of Trial Lawyers of America. They specifically cited his decisions upholding civil and individual rights and his application of innovative approaches to the legal process. It is with great pleasure that the members of the University of Minnesota Law School Class of 1983 welcome The Honorable Miles W. Lord.
