## **WALTER F. MONDALE**

**"Minnesota's Favorite Son" has a long distinguished record of service to the people of Minnesota and the United States. A graduate of the University of Minnesota Law School, Mr. Mondale began his career as a public servant as Minnesota Attorney General. From that office he went to the floor of the United States Senate. As a senator Mr. Mondale gained recognition for both his commitment to Civil Rights and as a voice for those often neglected by society. Mr. Mondale was the Vice-President of the United States from 1977-81 where he elevated the office from that of a mere "figurehead" through his active participation in the Carter Administration.**

**As Democratic nominee for President of the United States in 1984, Mr. Mondale remained committed to the causes and issues that drove him throughout his career in public service. His historic selection of Geraldine Ferraro as his running mate was further evidence of this commitment.**

**Mr. Mondale is currently engaged in the private practice of law as a partner in the law firm of Winston & Strawn. Although he has announced his retirement from public office, his ideas and principles continue to shape American politics.**
