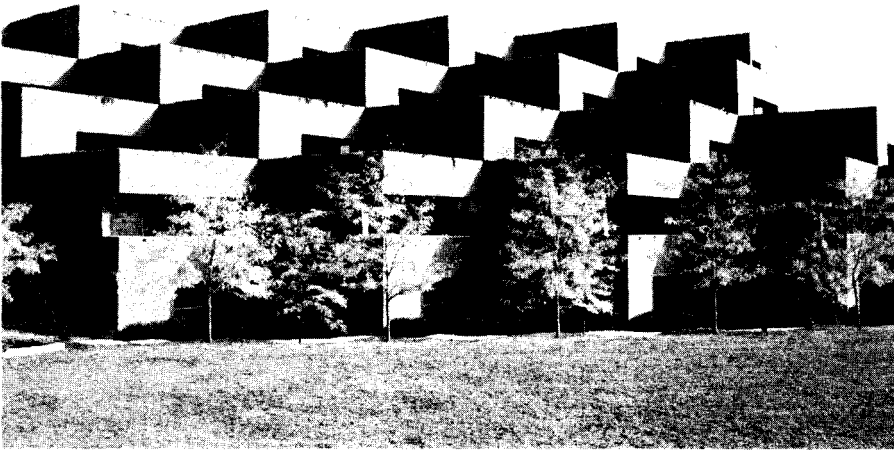

MARIAN WRIGHT EDELMAN

Ms. Edelman graduated from Spelman College in Atlanta, Georgia, in 1960 and from the Yale Law School in 1963. She directed the Mississippi office of the NAACP Legal Defense and Educational Fund, Inc., from 1964-1968. In the summer of 1968 she served as Congressional and Federal Agency Liaison for the Poor People's Campaign and began the Washington Research Project of the Southern Center for Public Policy later that year. From 1971 until May of 1973, Ms. Edelman was the Director of Harvard University's Center for Law and Education, while remaining part-time with the Washington Research Project. She became the Director of the Children's Defense Fund, which evolved out of the work of the Washington Research Project in 1973. Since 1973 Ms. Edelman has served on a number of boards, including the Yale University Corporation, the Carnegie Council on Children, the Board of Trustees of Spelman College, the German Marshal Fund and the NAACP Legal Defense and Educational Fund, Inc. Her efforts on behalf of children have made her a major voice in the continuing struggle against poverty and injustice. She has made the Children's Defense Fund work for children and in that way she has been working for a better future for America.
