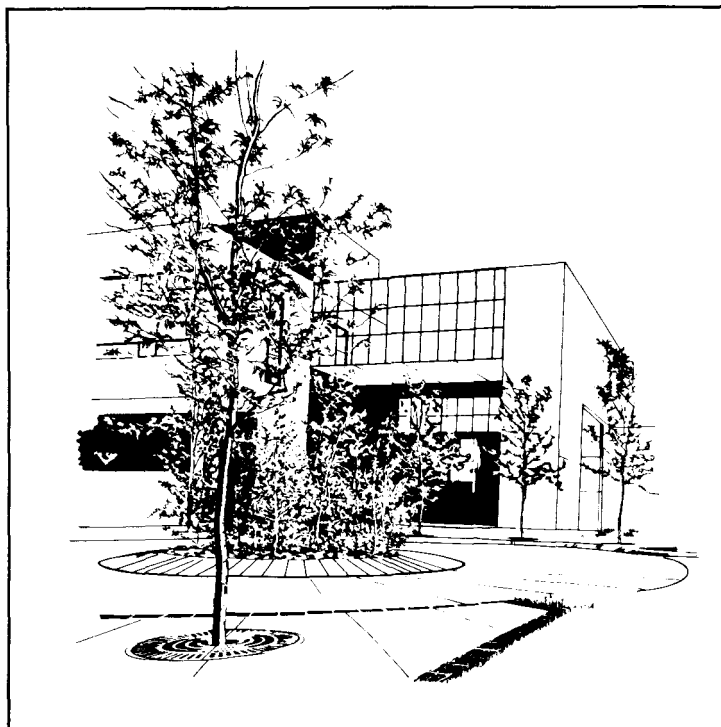

SENATOR JOSEPH R. BIDEN, JR.

Joseph R. Biden, Jr., received his Juris Doctor degree from Syracuse University in 1968. He served in private practice in Wilmington, Delaware until he was elected to the U.S. Senate in 1972 at the age of 29. He currently serves as Chairman of the Senate Judiciary Committee and also is a member of the Foreign Relations Committee.

Senator Biden has been described as one who is quick to sense what is troubling the public and to come up with plausible ways to attack the problem. He is also said to be aggressive and unashamed of his own ambitions. Perhaps because of such characteristics, he is frequently mentioned as a leading candidate for the 1988 Democratic Presidential Nomination.
