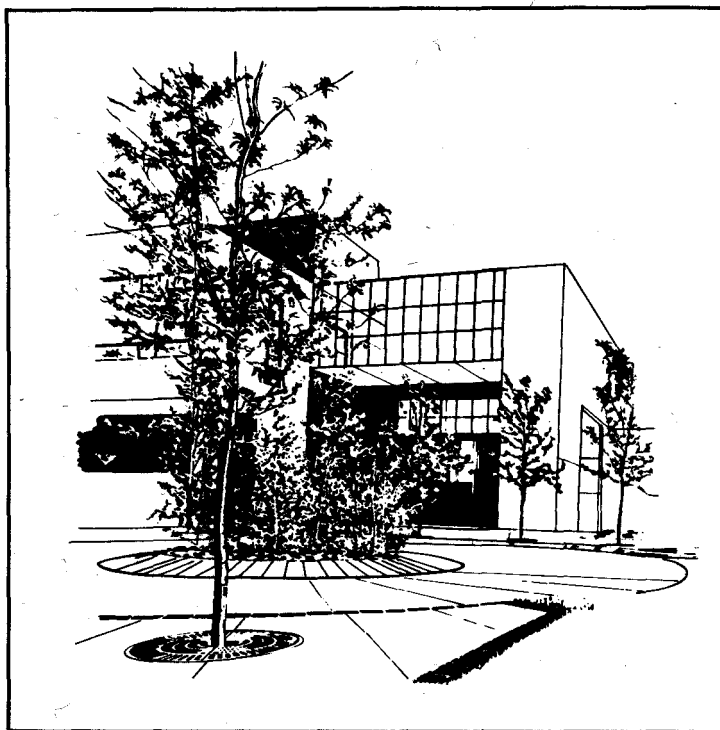

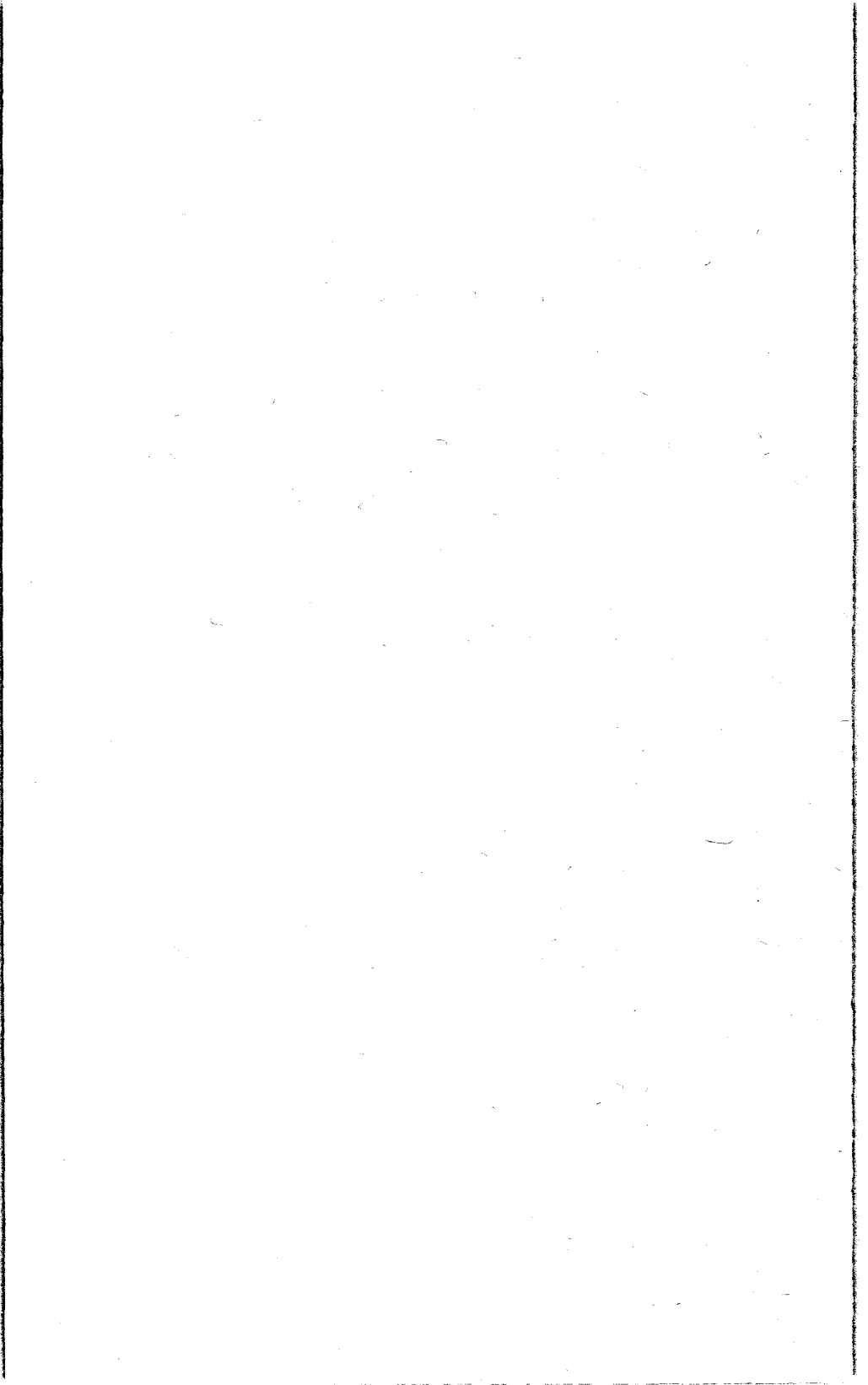

## JUDGE CARL B. STOKES

Carl B. Stokes was born June 21, 1927, and received his B.S.L. from the University of Minnesota in 1954. He received his LL.B. in 1956 from Cleveland Marshall Law School. He holds LL.D. degrees from the following schools: Cleveland Marshall Law School, Tufts University, University of Cincinnati, St. Francis College, Central State University, Wilberforce University, Lincoln University, Union College, Livingston College, Boston University, and Oberlin College.

Judge Stokes began his career as Assistant Prosecutor for the City of Cleveland in 1958. From 1962 to 1967, he served as a member of the Ohio House of Representatives. In 1967, the people of Cleveland elected him Mayor, an office he held until 1971. He served as a commentator for WNBC in New York City from 1972 to 1980, and currently holds the position of Chief Judge of the Municipal Court of Cleveland.

In addition to the above, Judge Stokes served as Honorary Chairman, 21st Congressional District Caucus from 1970 to 1972. He has also been a member of the Advisory Board of the U.S. Conference of Mayors, the Steering Committee of the National Urban Coalition, the Policy Committee of the National Democratic Committee, and the Executive Committee of the National League of Cities. Judge Stokes is the author of *The Quality of Our Environment* and various published articles. He has received numerous awards, including the Equal Opportunity Award, the National Urban League Award and the Horatio Alger Award.
