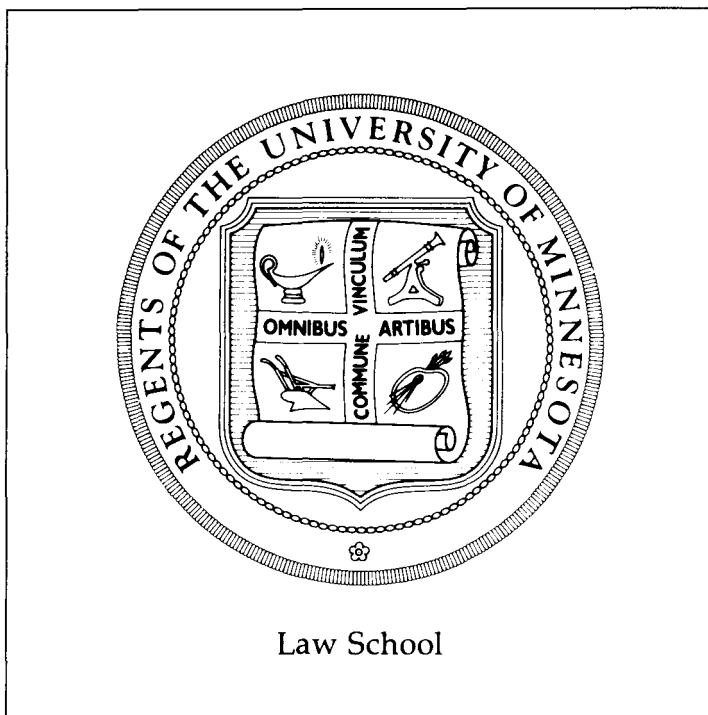

PATRICIA SCOTT SCHROEDER

Congresswoman Schroeder represents the First Congressional District of Colorado in the United States House of Representatives. Elected in 1972, Ms. Schroeder has been in the forefront of the progressive movement in the Democratic Party, taking leadership on critical issues of foreign and military policy, arms control and disarmament, women's economic equity, educational opportunity, and civil and constitutional rights.

Born in Portland, Oregon, Ms. Schroeder graduated magna cum laude from the University of Minnesota in 1961 and received her J.D. from Harvard Law School in 1964. Prior to her election to Congress, Ms. Schroeder practiced law in Denver, Colorado. She and her husband James have two children.

Ms. Schroeder is a member of the House Armed Services Committee, the House Judiciary Committee, the House Committee on Post Office and Civil Service, and the House Select Committee on Children, Youth and Families. She is also co-chair of the Congressional Caucus for Women's Issues, a bi-partisan group of representatives devoted to advancing women's legislation in Congress.

Random House released Ms. Schroeder's first book, *Champion of the Great American Family*, in February 1989. The book outlines her work on family issues and sets forth a family policy agenda for the 21st century.

The University of Minnesota Law School Class of 1990 warmly welcomes Congresswoman Patricia Schroeder to deliver the 101st Commencement Address.
