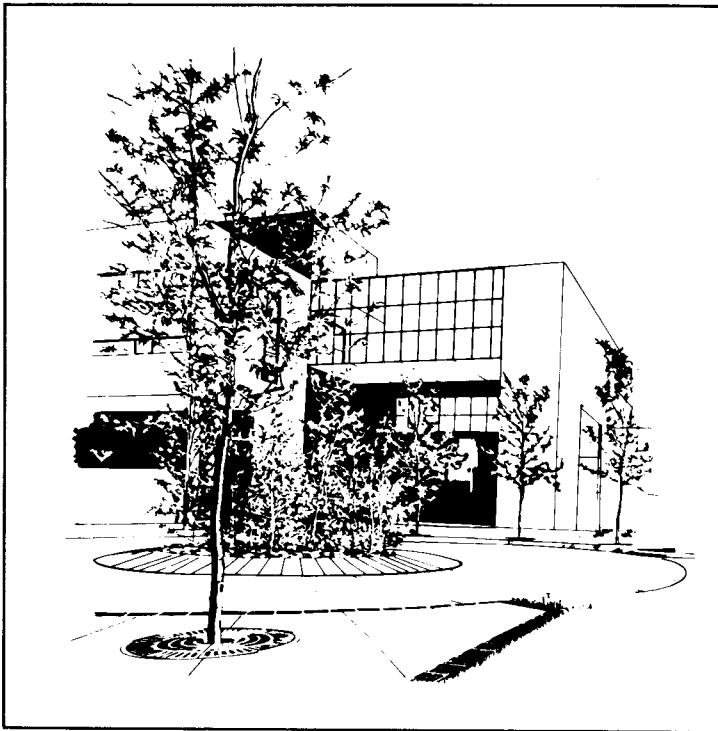

Harry T. Edwards

Judge Edwards is a Circuit Judge on the Washington D.C. Circuit. He was appointed in 1980 by President Carter.

Judge Edwards received his Bachelor of Science at Cornell University in 1962. He received his Juris Doctor at the University of Michigan in 1965, where he was the Assistant Editor of the Michigan Law Review, and graduated Order of the Coif.

Before being appointed to the D.C. Circuit, Judge Edwards was a Professor at the University of Michigan from 1970 to 1980. He also taught at Harvard Law School from 1975 to 1977.

Judge Edwards has published numerous books and articles, and has received several honors and awards including the American Lawyer, "Outstanding Performer" in legal profession for judicial opinions in labor law in 1982. Judge Edwards has also participated in many noteworthy rulings including *Sims v. Central Intelligence Agency* and *Doe v. Casey*.

Judge Edwards is highly regarded by his peers and is seen as bright and able. His opinions are considered scholarly and well-reasoned. Judge Edwards has frequently been mentioned as a candidate for appointment to the United States Supreme Court.
