Pamela F. Olson is the Acting Assistant Secretary (Tax Policy) for the United States Department of the Treasury. At Treasury, Pam has supervisory responsibility for the legal advice and analysis provided by the Office of Tax Policy with regard to all aspects of domestic and international issues of Federal taxation, including legislative proposals, regulatory guidance, and tax treaties.

Prior to her appointment as Acting Assistant Secretary, Pam was a partner with Skadden, Arps, Slate, Meagher & Flom specializing in the resolution of tax controversies; administrative practice; and transactional tax planning for debt and lease financings and for corporate mergers, acquisitions, and restructurings. She previously held positions with the Internal Revenue Service as Special Assistant to the Chief Counsel, as an Attorney-Advisor in the Legislation and Regulations Division, Office of Chief Counsel and as a trial attorney for the San Diego District Counsel.

Pam received the following degrees from the University of Minnesota: B.A. magna cum laude (1976), J.D. (1980) and M.B.A. (1984). She is a member of the Bar of the District of Columbia, United States Tax Court, and United States Supreme Court and served as Chair of the American Bar Association Section of Taxation immediately prior to her Treasury appointment. She is a Fellow of the American College of Tax Counsel; a Fellow of the American Bar Foundation; and a Trustee of the American Tax Policy Institute. She is a frequent speaker on continuing legal education topics and has published several articles. She also served as federal tax advisor to the National Commission on Economic Growth and Tax Reform.
