**President of the American Civil Liberties Union**  
**Professor of Law, New York Law School**

Nadine Strossen, Professor of Law at New York Law School, has written, lectured and practiced extensively in the areas of constitutional law, civil liberties and international human rights. Since 1991, she has served as President of the American Civil Liberties Union, the first woman to head the nation's largest and oldest civil liberties organization.

The National Law Journal has twice named Professor Strossen one of "The 100 Most Influential Lawyers in America." In 1998, Vanity Fair Magazine included Strossen in "America's 200 Most Influential Women." In 1999, Ladies Home Journal included Strossen in "Americas's 100 Most Important Women."

Professor Strossen graduated Phi Beta Kappa from Harvard College (1972) and magna cum laude from Harvard Law School (1975) where she was an editor of the Harvard Law Review. Before becoming a law professor she practiced law for nine years in Minneapolis and New York.
