### **1. INTRODUCTIONS AND REVIEW OF PAST COMMITTEE WORK**

David Nelsen welcomed members to the committee and provided an opportunity for introductions. He then reviewed the work of the committee during his three years of service, noting that the committee has expressed passion on a variety of topics during this time.

### **2. 2008-09 AGENDA ITEMS**

Members then discussed the following potential agenda items for this year:

- Usage data and coverage for dental insurance, especially Duluth coverage and rates
- Update on the disability insurance RFP
- Interprofessional education – was a student advisory group formed and how can programs work together more
- Clinical lab space (IERC) – current access and possibility for increase in space
- Economic impact on health care – worsening economy is translating into fewer preventive visits to the doctor and dentist; students need to be educated that this is an issue
- Third party health insurance versus the University policy
- Mortuary Science being involved in the anatomy memorial service – there are bad feelings after Mortuary Science students were excluded last year
- Presentation to the Deans on what the committee has done and future items
- Interdisciplinary outreach
- Highlighting each program one day per year to increase visibility and foster relationships

### **3. FOOD AND DRINKS AT MEETINGS**

The Senate leadership discussed eliminating food and drink at committee meetings. For student committees, the final decision was left up to each committee. The AHC SCC decided that it would prefer to have a pizza dinner once per year or semester, if possible. If this option is not possible, then it will continue with the traditional snacks and drinks. Members also discussed volunteering to bring a healthy option to meetings, whether or not pizza is being served.
