III. REPORT OF THE NOMINATING COMMITTEE FOR THE TWIN CITIES ASSEMBLY STEERING COMMITTEE

Reported for Action by the Faculty Assembly

The Special Nominating Committee (approved by the Assembly October 24, 1974) to fill 1975-78 faculty membership terms on the Assembly Steering Committee presents the following four names, from which two (2) are to be elected:

(Dates are dates of initial appointment at the University.)

Edward Foster: 1961; Professor, Economics; Senate/Assembly alternate, 1974-75.

Kenneth H. Keller: 1964; Professor, Chemical Engineering and Materials Science; Senate/Assembly member, 1971-74; Senate Committee on Research, Vice President's Ad Hoc Committee on Student Affairs.

Peter H. Robinson: 1966; Associate Professor, French and Italian, Director of Honors, College of Liberal Arts; Senate/Assembly member, 1972-75; Committee on Committees, Ad Hoc Committee on Faculty Accountability.

Barbara Stuhler: 1950; Professor, World Affairs Center; Senate/Assembly member, 1966-69, 1972-75; Committee on Committees, Committee on Resources and Planning, Task Force on Academic Salaries, Ad Hoc Committee on Faculty Accountability, Campus Committee on Convocations and the Arts, University Committee on Foreign Students.

The Assembly Steering Committee is also the Assembly Executive Committee and forms the Twin Cities membership of the Senate Consultative Committee. Additional nominations, certified as available, may be made by: (1) petition of 12 voting members of the faculties, provided that the petition is in the hands of the clerk of the Twin Cities Assembly the day before the Twin Cities Assembly meeting; (2) nomination on the floor of the Assembly. The faculty representatives of the Twin Cities Assembly shall reduce by vote the slate to twice the number to be elected, and shall forward the results to the clerk of the University Senate.

The University Senate Bylaws provide that the clerk of the Assembly shall distribute, by mail, election ballots and slates to all faculty eligible to vote for members of the Senate and shall receive all returns.

IV. REPORT OF THE ASSEMBLY COMMITTEE ON INTER-COLLEGIATE ATHLETICS

Reported for Information

Item 1: Changes to Rule 3 and Rule 7 of the Intercollegiate (Big Ten) Conference.

Over the past several years, the faculty representatives have attempted to modify the requirements for eligibility and grants-in-aid so that a larger proportion of athletes would graduate. The new rules are as follows:

RULE 3, SECTIONS 1 AND 2

Section 1. General Requirements. A student to be eligible for competition must be making normal quantitative progress toward meeting the requirements for the student's baccalaureate degree objective and have a satisfactory cumulative grade average.

Section 2. Quantitative Requirements. A student must enroll and progress in a program of studies through which the student can qualify for a baccalaureate degree within no more than five years.

- (a) To be eligible for competition in a student's first school year of residence, the student must have graduated from a high school with a minimum accumulative 6, 7 or 8 semester grade point average of 2.000, on a 4 point scale for all work taken and certified officially on the high school transcript, and achieved at the student's University the minimum full work requirement for the number of terms (excluding summer session) that the student has been enrolled.
- (b) To be eligible for competition in a student's second school year of residence (whether he competed in the first year or not), the student must have earned at least the number of scholastic credits acceptable toward the student's baccalaureate degree objective which constitutes one academic year of work as measured by the minimum full work requirement at the student's University (but not less than 24 semester hours or 36 quarter hours of work).
- (c) To be eligible for competition in a student's third school year of residence (regardless of previous competition), the student must have earned at least the number of scholastic credits acceptable toward the student's baccalaureate degree objective which constitutes two academic years of work as measured by the minimum full work requirement at the student's University (but not less than 51 semester hours or 77 quarter hours of work).
- (d) To be eligible for competition in a student's fourth school year of residence (regardless of previous competition), the student must have earned at least the number of scholastic credits acceptable toward the student's baccalaureate degree objective which constitutes three academic years of work as measured by the minimum full work requirement at the student's University (but not less than 78 semester hours or 117 quarter hours of work).
- (e) To be eligible for competition in a student's fifth school year of residence, the student must not have competed during more than two seasons after his first year in residence, and must have earned at least the number of scholastic credits acceptable toward the student's baccalaureate degree objective which constitutes four academic years of work as measured by the minimum full work requirement at the student's University (but not less than 105 semester hours or 158 quarter hours of work).
- (f) In the case of a student who changes from one curriculum to another, eligibility for competition for the first year after the change shall be determined by the quantitative requirements stated above based upon all of the student's college work recognized by the University at the time of such change. In the case (Rule 2, Section 2) of a student coming from a branch or extension center, or a junior college in accordance with Rule 2, Section 3, eligibility for competition for the first year after transfer shall be determined by the quantitative requirements stated above based upon all of the student's college work accepted by the certifying institution at the time of transfer.
- (g) A student who changes from another curriculum or college within the University, or who transfers from another institution of college grade, must meet the requirements stated above no later than one year after the student's enrollment in the new curriculum, college or university.

RULE 7, SECTION 3 (a) (b) (c)

- (a) *Qualifications for University Grants-In-Aid.* A student shall not be eligible for a grant-in-aid under this Section unless the student meets the following requirements:
- (1) A student during the first year of residence (other than a transfer student) shall have graduated from a high school with a minimum accumulative 6, 7 or 8 semester grade point average of 2.000 on a 4 point scale for all work taken and certified officially on the high school transcript. A transfer student other than one who is eligible for competition in accordance with Rule 2, Section 3, shall not be eligible for a grant-in-aid under this Section in the student's first year of residence.
 - (2) Any other student, at the end of the student's immediately preceding academic year (including summer session, if attended) shall have met all the prerequisites for eligibility which are established by the Conference and his University.
 - (á) To be eligible for a grant-in-aid during the student's second school year, the student must have earned at least 24 semester hours or 36 quarters hours which are acceptable toward meeting requirements for the student's baccalaureate degree objective.
 - (b) To be eligible for a grant-in-aid during the student's third school year, the student must have earned at least 51 semester hours or 77 quarter hours which are acceptable toward meeting the requirements for the student's baccalaureate degree objective.
 - (c) To be eligible for a grant-in-aid during the student's fourth school year, the student must have earned at least 78 semester hours or 117 quarter hours which are acceptable toward meeting the requirements for the student's baccalaureate degree objective.
 - (d) To be eligible for a grant-in-aid during the student's fifth school year, the student must have earned at least 105 semester hours or 158 quarter hours which are acceptable toward meeting the requirements for the student's baccalaureate degree objective.
- (b) Insert Rule 7, Section 5 without change and renumber accordingly.
- (c) Insert Rule 7, Section 3 (b) without change—Aid limited to basic costs of education.

The following comments were prepared by our faculty representative Merle K. Loken.

1. Changes to Rule 3, Sections 1 and 2 and Rule 7, Section 3(a) were considered to be substantial and were referred to each Big Ten institution for action. These changes were discussed at length by our ACIA after which both were approved in principle with the condition that certain editorial changes be made. These editorial changes were made at the time of the December 2-4, 1974 meeting of Faculty Representatives in Chicago. Both changes were then passed unanimously by the Faculty Representatives. These matters are now to be reported to The Twin Cities Assembly for information.
2. The background leading to these changes is as follows:
 - a. There was a need to spell out more clearly the year by year requirements both for eligibility to compete in athletics and thus be eligible

for a grant-in-aid. This need became more evident after the passage of changes to Rule 1 permitting freshman eligibility in all sports.

- b. On June 1, 1973, Rule 3, Section 2 was changed to require a higher quantitative requirement for eligibility than had been in effect previously (i.e., completion of 81 quarter hours for a third year of eligibility and 126 quarter credits for a fourth year). This also meant that unless this quantitative progress was made (which incidentally is greater quantitative progress toward a degree than is obtained by a significant percentage of students who are non-athletes) the athlete was also ineligible for a grant-in-aid.
- c. At that time the special (black) commission of the Big Ten proposed a two track system, one for eligibility for competition (higher quantitative progress) and one for eligibility for a grant-in-aid (less quantitative progress). This was considered to be an untenable situation, so that a compromise was reached.
- d. It is our hope that the compromise as proposed will encourage student athletes to obtain a college degree but will not be so stringent as to cause athletes to become discouraged and drop out of school because the progress requirements are too difficult to achieve.
- e. An incidental consideration in these rule changes was to eliminate any reference to the sex of the athlete (note that "student" athlete is used throughout). This was thought to be a significant step as we move toward implementation of Title IX and with this, a single set of rules in the Big Ten that might eventually apply to men and women athletes alike.

As Merle Loken indicated, the Assembly Committee on Intercollegiate Athletics instructed the faculty representative to cast Minnesota's vote in support of the change.
