### **New Report: Social Networking and Privacy on the Web**

OCLC has released the third in a series of reports that scan the information landscape to provide data, analyses and opinions about users' behaviors and expectations in today's networked world. The new international report, *Sharing, Privacy and Trust in Our Networked World*, examines four primary areas:

- Web user practices and preferences on their favorite social sites
- User attitudes about sharing and receiving information on social spaces, commercial sites and library sites
- Information privacy, what matters and what doesn't
- U.S. librarian social networking practices and preferences; their views on privacy, policy and social networks for libraries

"We know relatively little about the possibilities that the emerging social Web will hold for library services," said Cathy De Rosa, Global Vice President of Marketing, OCLC, and principal contributor to the report. "More than a quarter of all Web users across the countries we surveyed are active users of social spaces. As Web users become both the consumers and the creators of the social Web, the implications and possibilities for libraries are significant. The research provides insights into what these online library users will expect."

Among the report highlights:

- The Internet is familiar territory. Eighty-nine percent of respondents have been online for four years or more, and nearly a quarter have been using the Internet for more than 10 years.
- The Web community has migrated from using the Internet to building it -- the Internet's readers are rapidly becoming its authors.
- Library Web site usage has declined from 30 percent of respondents in Canada, the U.K. and the U.S. in 2005 to 20 percent in 2007, a 33 percent decrease.
- More than a quarter of the general public respondents currently participate on some type of social media or social networking site; half of college students use social sites.
- On social networking sites, 39 percent have shared information about books they have read, 57 percent have shared photos/videos and 14 percent have shared self-published information.
- Over half of respondents feel their personal information on the Internet is kept as private, or more private, than it was two years ago.
- Online trust increases with usage. Seventy percent of social networking users indicate they always, often or sometimes trust who they communicate with on social networking sites.
- Respondents do not distinguish library Web sites as more private than other sites they are using.
- Thirteen percent of the public feels it is the role of the library to create social networking sites for their communities

## CATALOGING & METADATA

### Level 3 MARC Records

Since last summer there has been a vigorous, sometimes angry, discussion about level 3 MARC records in WorldCat. These are abbreviated records that do not meet Minimal-level cataloging specifications. They have been around for some time for use in special projects, but recently they've become more common and controversial as Baker & Taylor and other vendors add them to WorldCat.

Some librarians question the quality of these records -- calling them 'annoying,' 'a nuisance,' and 'useless imposters' -- and complain they demand too much work to make them useful to library users. When searching WorldCat, catalogers can discover that the only matches they find are level 3 records containing little useful information. Consequently, they find themselves spending time either upgrading these records or creating new ones to avoid the hassle of cleaning up what they did find.

OCLC has responded to complaints by saying that they are trying to satisfy the needs of a variety of WorldCat users. Level 3 records are not intended for cataloging use as they are. Level 3 vendor records have been added into WorldCat in an effort to make records available earlier in the acquisitions process. OCLC is working with Baker & Taylor to improve the quality of that vendor's records. In the meantime, they are urging us not to create new, duplicate records but to upgrade the level 3 records we encounter. (Please note that libraries that upgrade these records receive an enhancement credit of \$3.20)

MINITEX and other regional service providers have been talking with OCLC about this situation. Things may improve in the near future, but there are no guarantees. Please avoid adding duplicate records to WorldCat. As an alternative, if you find inadequate level 3 records in WorldCat, you could create a brief record in your local database and, then, search again in a couple of weeks in the hope of finding better records for your items. That's not an ideal solution, but it could save some work.

### **Blackwell Book Services Now a WorldCat Selection Service Partner**

WorldCat Selection subscribers can now receive notification records for Blackwell Book Services materials within the WorldCat Selection interface. WorldCat Selection, based on ITSO CUL (Integrated Tool for Selection and Ordering at Cornell University Library), allows selectors of library materials to view new title data from multiple materials vendors in one central,

comprehensive system. Libraries are able to get WorldCat records for newly selected materials into their integrated library systems early in the technical services process, as well as share selection decisions with others in their institutions.

## **LOCAL HOLDINGS MAINTENANCE**

### **Keeping Local Holdings Records Accurate**

In the 18 months since Local Holdings Maintenance migrated to the Connexion Browser, there has been a noticeable decline in the number of LHR updates that are received in the MINITEX/MULS office. We'd like to get a better picture of the factors that have led to this change in activity and whether there are changes we can make that would help our participating libraries keep holdings up-to-date.

All libraries participating in the MULS union list group have committed to keeping their serial holdings information up-to-date. Libraries with access to OCLC are supposed to receive training so their staff can input and update their Local Holdings Records (LHRs) at their convenience. Libraries without access to OCLC are expected to send updates of their serial holdings to the MINITEX/MULS office, where our staff will make the necessary changes to the libraries' LHRs.

Perhaps some of the changes that accompanied the migration to Connexion are effecting how easily libraries can create lists to update their holdings. On the other hand, it may be that the factors effecting LHR updating have more to do with local or regional changes that demand more staff time.

Rather than guessing, we'd like to hear from our participating libraries to get a clearer picture of the factors that have contributed to the decline we've seen in the number of Local Holdings Record updates. If your library participates in the MULS union list, and your staff does not directly update the library's holdings in OCLC, we'd like to know:

1. Does your library maintain a local record (as part of the catalog or separately) of your serials holdings? How is it updated, and how often?
2. Has your library sent updates to the MINITEX/MULS office for updating in OCLC? How recently? Have you added or deleted titles from your serials collection since then?
3. What are the obstacles or factors that affect your ability to send updates to MULS? Do you see some way (or ways) that the MINITEX/MULS unit could help make updating easier?

Please contact Dave Linton in the MINITEX/MULS office with your responses to any – or all – of these questions (Contact information at the end of this *Mailing*). We'd like to find out how we can help keep the holdings data in MULS accurate, so it can benefit our entire community.
