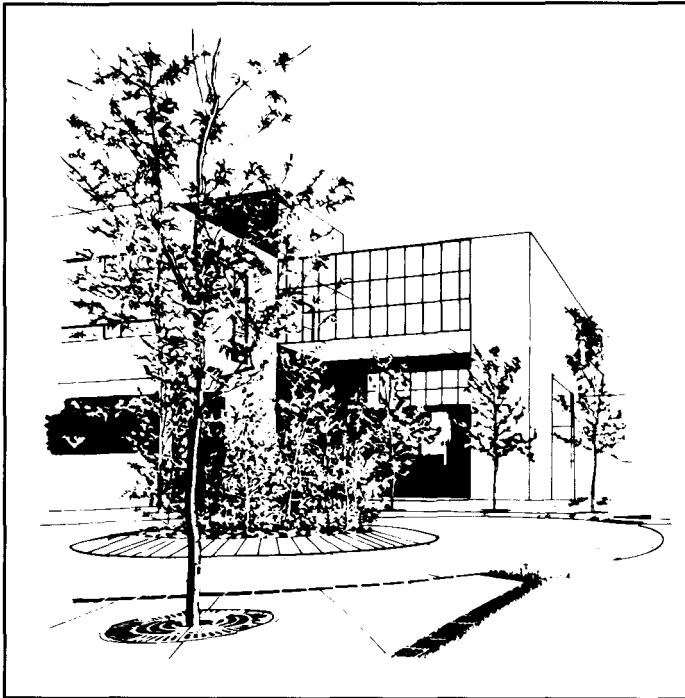

Justice Joyce L. Kennard

Justice Joyce L. Kennard was appointed to the California Supreme Court in 1989. She previously served as Associate Justice of the California Court of Appeal and as Superior Court Judge in Los Angeles. Before taking the bench, Justice Kennard served as Senior Attorney with the State Court of Appeal and as Deputy Attorney General, Los Angeles.

Justice Kennard has had an extraordinary life. Born in West Java, Indonesia, she and her mother spent three years interned in a Javanese war camp. They later immigrated to Dutch New Guinea and subsequently to Holland, where Justice Kennard began high school. In 1961, Justice Kennard moved to the United States. She was naturalized as a United States citizen in 1967.

Justice Kennard received her Associate of Arts degree from Pasadena City College and her Bachelor of Arts degree from the University of Southern California. She continued her graduate and professional studies at the University of Southern California and received a Juris Doctor, as well as a Master of Public Administration, in 1974.

Justice Kennard's numerous honors celebrate her outstanding jurisprudential contributions, as well as her multi-racial heritage. In 1992, the Netherlands-American Arts and Cultural Foundation awarded her its first Netherlands-American Heritage Award for contributions by people of Dutch origin to the political, economic, and cultural growth of the United States. The same year, the Chinese Historical Society of Southern California presented her with the Chinese-American Pioneers in the Judiciary Award. In 1993, Justice Kennard was a recipient of the American Bar Association's prestigious Margaret Brent Women Lawyers of Achievement Award which commemorates the accomplishments of outstanding women lawyers.

Justice Kennard's "cutting edge" opinions seek justice for those facing inequity and adversity. She is cited frequently for her commitment to preserving access to the court system for minorities, women, and the poor, and her written judicial opinions reflect her support of human rights and dignity.
