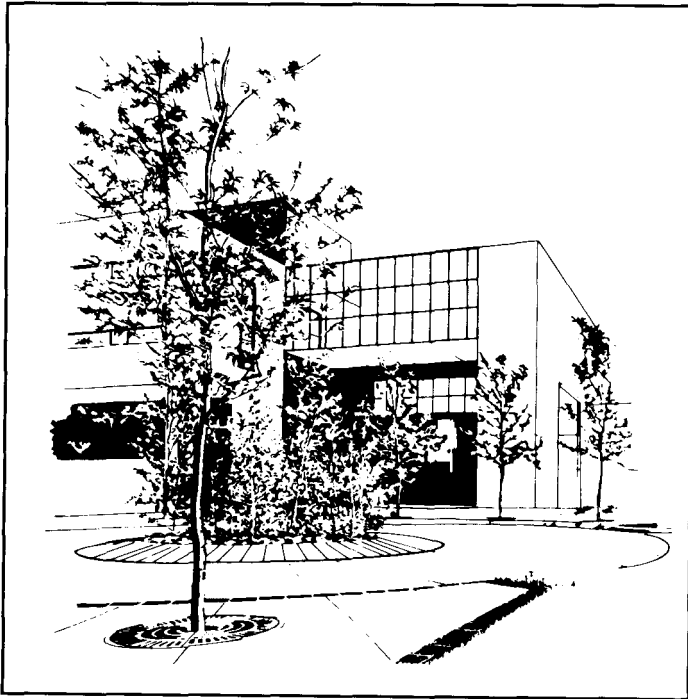

The Honorable James J. Blanchard United States Ambassador to Canada

James J. Blanchard is the United States Ambassador to Canada. He has been involved in numerous trade, natural resources, environmental, and national security issues between the United States and Canada.

James Blanchard previously served as Governor of Michigan from 1983-1991. As Governor, he worked with the private sector to attract business investment and trade from around the world and won national acclaim for his innovative approaches to economic development, education, crime fighting, environmental protection, and helping children and families. He was awarded the International Freedom Festival's Freedom Award in recognition of his leadership in United States-Canadian affairs.

Ambassador Blanchard also served as Assistant Attorney General of Michigan (1969-1974) and was elected to four terms as a member of the United States House of Representatives (1975-1983).

Ambassador Blanchard earned a B.A. Degree in History and an M.B.A. Degree from Michigan State University and received his J.D. Degree from the University of Minnesota in 1968. He has received Honorary Doctor of Laws Degrees from the University of Michigan, Michigan State University, Wayne State University, Oakland University, and Alma College.

Ambassador Blanchard is the recipient of numerous honors and awards, including the 1991 INC. Magazine Supporter of Entrepreneurship Award, the Jewish National Fund's Tree of Life Award, and the University of Minnesota's Outstanding Achievement Award which was presented to him during the Law School's Commencement exercises in 1984.

Ambassador Blanchard is married to Janet Blanchard, a former Associate Director of Personnel in the White House. He has one son, Jay, who is a recent graduate of Michigan State University.
