John Beusterien is Associate Professor of Spanish and Director of the Comparative Literature Program, Texas Tech University. He has published studies on the history of race in early modern Spain. His other research interests include: the history of Spanish in the American Southwest, Cervantes, and the cultural history of animals.

Frédéric Conrod is Assistant Professor of Comparative Literature, Florida Atlantic University. His area of expertise is the correspondence between the Spanish Golden Age and the French Enlightenment. Past writings have dealt with one dimension of this problematic: the repercussion of the Ignatian exercises on the rise of the novel, and particularly their direct consequences on the writings of the Marquis de Sade.

Constance Cortez is Associate Professor of Art History, Texas Tech University. She has published studies on Pre-Columbian and Colonial Arts of the Americas as well as on Contemporary Latina/o Art. Her other research interests include post colonial theory and globalization and the arts.

Carolyn Dean is Professor of History of Art & Visual Culture, University of California, Santa Cruz. Her scholarly interests focus upon Inka visual culture in both Pre-Hispanic and Spanish colonial periods.

Lori Boornazian Diel is Associate Professor of Art History, Texas Christian University. Her research focuses on Aztec art and specifically on pictorial documents that were created by indigenous artists after the conquest.

Lauren Kilroy is Assistant Professor of Art History, Brooklyn College (CUNY-Brooklyn). Currently, she is interested in representations of the body and body parts in colonial Latin America, examining how such images relate to political, social and religious discourses. In this regard, she also critiques the problematic of the genre of colonial portraiture in which power, gender, and race are projected as normative states of social being.
