



DEGREES IN HOUSING: AN INTRODUCTION TO THE GRADUATE HOUSING PROGRAM

While courses are offered in many departments throughout the University, there is only one department in which a degree in housing can be obtained. The Graduate Housing Program, located within the Design Department of the College of Home Economics, provides an interdisciplinary approach to the study of housing. The interaction between people and their housing environment is viewed from many perspectives including esthetic evaluation, human needs, economic resources, and public policy.

The Program offers both a Master of Arts (M.A.) and a Doctor of Philosophy (Ph.D.) degree. Students at either level have the opportunity to create highly individualized programs with the options of using previous academic and professional experience as a base from which to draw. Each program, subject to Department and Graduate School approval, may use the many resources of the whole University and the particular expertise of individual graduate faculty members. Students may combine their study of housing with various aspects of such diverse areas as aging, public policy, urban planning, interior design, sociology, or architecture. It is also possible to use housing as a minor or supporting field, while obtaining a major in another department.

Housing courses offered through the Design Department must be supplemented with courses from other departments for both graduate degrees.

Applicants to the Doctoral Program who have not completed a Master's Degree may not be admitted directly into the Ph.D. Program, but should apply first, for admission to the Master's Program in Design majoring in housing. Ph.D. students, after completion of three quarters' study, are required to submit an official program and may either propose another field as a minor or related fields as supporting areas. There are no foreign language requirements, although familiarity with a foreign language is recommended and may be necessary if a student wishes to pursue research of an international nature that involves field work abroad.

Students pursuing housing study at any graduate level must be admitted to the Graduate School of the University of Minnesota as well as the Design Department. Each student is responsible for meeting graduate school as well as department procedures and requirements. For additional information regarding admission procedures as well as general degree requirements, refer to the Graduate School and the Design Department Bulletins.

An undergraduate program emphasizing the study of family needs and problems in relation to shelter is also offered. Students take major courses in the Design and Family Social Science Departments. The Program offers three options - design, business, and social services - or an opportunity to take a cross-option for a more general housing background. One of the strengths of the housing program is its field experience. Each student is required to spend a minimum of 400 hours (one academic quarter) working in the community to gain practical work experience in housing.

COURSE LISTINGS

The following listing of courses relevant to housing is offered only as a guide to inform students about courses they may wish to consider. Each person is urged to obtain further information about courses and programs of study from bulletins of the colleges, schools, and related departments involved.

Courses are listed under the department in which they are offered. Some courses have no description. Departments should be contacted regarding specific information. To learn the hour and place each course is offered consult the quarterly Class Schedules.

New courses are always being developed and old courses revised or dropped; hence this listing may not be totally complete or accurate.

Course Numbering System

Courses numbered at the 5000-level may be taken by juniors, seniors, adult specials, and graduate students unless otherwise indicated.

Courses numbered at the 8000-level are for graduate school registrants only.

Course symbols

The following symbols are used to explain listed courses:

- # means consent of instructor is required prior to registration.
- + means all courses preceding + must be completed before credit will be granted for any quarter of the sequence.

Impact of legislative, regulatory, and judicial policies upon consumers examined for their tendency to promote efficiency, equity, consumer sovereignty, and freedom of choice. Policies for dealing with information, prices, consumer protection, consumer redress, public goods, and regulatory institutions evaluated.

Economics concepts applied to analysis of household production, market and nonmarket work, family formation and size, and household consumption activity.

Major components of landscape; emphasis on interaction between structures created by people and distinctive rural landscapes in North America, Northwestern Europe.

Survey of ideas on environmentalism with emphasis on those that lead to the organization of the physical environment into human settings (rural and urban) in the belief that they affect life's ideas.
- ** 5849 SPACE AND PLACE: A GEOGRAPHY OF EXPERIENCE (4 cr)
How experience creates structure and meaning in space and environment.
- ** 8340 SEMINAR: LAND USE PLANNING (3 cr; prereq #)
- ** 8350 SEMINAR: SETTLEMENT AND POPULATION GEOGRAPHY (3 cr; prereq #)

Examination of relevant literature is followed by research projects in the local area. - *** 5004 PROPERTY I (3 cr)
Legal doctrines relating to personal property, real property, estates in land, future interests, concurrent interests, and landlord-tenant law.
- ** 5113 STATE AND LOCAL TAX (4 cr)
Legal and most of the economic issues presented by the various forms of taxation and finance used by state and local governments. Sales tax, property tax, corporate and personal income tax, bonds and government indebtedness as well as the fiscal crises of state and local governments.
- ** 5201 LAND USE PLANNING (3 cr)
Public control of land use and development, primarily in metropolitan areas. Problems considered are of increasing importance to lawyers whose practice involves them in the affairs of local governments or in real estate transactions.
- ** 5208 LOCAL GOVERNMENT LAW (3 cr)
The distribution of decision-making power between the state and other units of government. The proper role of the courts in reviewing the decisions of other units of governments.
- * 5213 MODERN REAL ESTATE (4 cr)
Major problem areas of current real estate law practice with emphasis on the legal handling of contemporary commercial and residential real estate transactions; including attention to devices such as mortgages and contracts for deed.
- ** 5215 ENVIRONMENTAL REGULATION (3 cr)
Legal aspects of major environmental problems, with emphasis upon pervasive issues that reappear in various regulatory contexts; e.g. who should bear the cost of enhancing environmental quality, the allocation of responsibilities among courts, legislatures, and administrative agencies, the role of citizen's groups and environmental litigation, environmental policy acts, etc.
- ** 5221 COMPREHENSIVE RESOURCE MANAGEMENT (3 cr)
Analysis of several specific techniques and programs for environmental preservation, with primary emphasis upon open space preservation. Topics include shoreland zoning in Minnesota, water surface zoning, preservation of scenic rivers, drainage and preservation of wetlands, scenic easements, aesthetic zoning, floodplain zoning, property tax law and the environment, cluster developments, etc.

- ** 5606 ADMINISTRATIVE LAW (4 cr)
Function of administrative agencies in our society: legislative, judicial and executive control of administrative agencies; interrelations of legislative, judicial, executive, and administrative agencies in development of public policy.
- ** 5621 CIVIL RIGHTS (4 cr)
Federal and state remedies for discrimination on the basis of race, religion, ethnic background, sex, or age in areas of voting rights, education, the administration of justice, employment, housing, public accommodations, and health and welfare services, where such discrimination is applicable.

Intensive work on selected problems concerning environmental protection and resource allocation, such as lakeshore zoning, regulation of the environmental effects of electric power plants, and the operations of the Minnesota Pollution Control Agency.

Case studies to develop analytic skills and provide insight into management problems.

Development and application of behavior principles, methods, and skills which underlie managerial competence in preventing and solving problems within and between individuals and groups and aid in effective utilization of human resources. Various laboratory procedures used to highlight concepts, methods, and skills and furnish practice in applying them to management problems.

- ** 5315 STATE GOVERNMENT (4 cr; prereq 1001 or #)
Description and analysis of political institutions and behavior in American states; involves interstate comparisons and comparisons between state and national political systems.
- ** 5321 AMERICAN ECONOMIC POLICY (4 cr; prereq 1001 or #)
Economic policy making processes; examination of several major policy issues such as fiscal and monetary policy, subsidies, economic regulations, and direct controls; assessment of governmental impact on the private economic sector.
- * 5322 AMERICAN SOCIAL POLICY (4 cr; prereq 1001 or #)
American government actions affecting the distribution of social benefits such as health care, education, and housing; social burdens such as taxation and regulation of social conduct. Focus on relationships between government action and social problems, with attention to possibilities for change.
- * 5327 LOCAL GOVERNMENT (4 cr; prereq 1001 or #)
Development and role of American local government; forms and structures; relationships with states and the federal government; emphasis on local politics and patterns of power and influence.
- * 5328 METROPOLITAN GOVERNMENT AND POLITICS (4 cr; prereq 1001 or #)
Development of modern American metropolis with emphasis on central cities and suburbs; intergovernmental relationships in the metropolis; state and federal responses to metropolitan problems; politics of reforming metropolitan government.
- ** 5739 POLITICS OF ETHNIC COMMUNITIES (4 cr; prereq 6 cr soc sci)
Cross-cultural study of politics of ethnic communities with emphasis on politics of black communities in the United States. Topics in community politics and local and national political systems.
- ** 8305 SEMINAR: INTEREST GROUPS (3 cr; prereq #)
Description and analysis of role of interest groups; leadership, maintenance of following, and representation of values; theories of groups, group behavior, and overlapping group membership; interest group relations with other political organizations.

- ** 8307 SEMINAR: POLITICAL LEADERSHIP AND DECISION MAKING (3 cr; prereq #)
Theories of political leadership; social and cultural support of leaders; description and analysis of leadership recruitment and rejection; decision making, choice, and bargaining in political organization.
- ** 8312 SEMINAR: LEGISLATIVE PROCESS (3 cr; prereq #)
National and state legislature; their internal organization; party organizations and influences with legislatures; interest groups and other external influences; legislative roles and behavior; policy-making processes in American legislatures.
- ** 8335 SEMINAR: PUBLIC POLICY (3 cr; prereq #)

Student research and review papers required.
- * 5151 ENERGY AND ENERGY POLICY (4 cr; § 3151; prereq #)
Fuel and energy supply and demand; environmental, social, and economic implications; alternative energy policies; means to affect changes in use patterns; political and institutional factors; relation of energy policy to economic, foreign, and environmental policies.
- ** 5152 TOPICS IN ENERGY POLICY (4 cr; prereq 5151 or #)
A facet of energy policy will be considered in detail. The topic will be selected each year on the basis of current activities in the general area of state, federal, or international energy policy.

- ** 5502 LOCAL ADMINISTRATION (4 cr)
Lecture-discussion and laboratory treatment of local public agencies in the political system and of the individual in those agencies. Emphasis on tools available to administrator to control or change local public agencies and on constraints under which he/she must work.

Examine role of American national, state and local governments in financing control, taxation, and construction of housing.

The role of American national, state, and local governments in financing, control, taxation, and construction of housing.
- ** 5516, 5517 SEMINAR: SOCIAL THEORY AND SOCIAL PLANNING I, II (4 cr per qtr; prereq # for 5516...5516 for 5517)
Major contemporary theories of societal guidance; what the planner has done and can do with regard to social goals and problems; examples from national, state, and metropolitan planning.
- ** 5550 PLANNING PROSEMINAR (2 cr; prereq #)
Analysis and discussion of major areas of planning, planning theory, planning methods, comparative planning, social planning, program planning, private sector development. Topics differ from quarter to quarter.
- ** 5562 CASE STUDIES IN PLANNING AND PLAN MAKING (3 cr; prereq #)
Planning strategies, plan format and content, plan preparation, and how these change with time. Related to public attitudes and issues: work with elected officials, citizens, private sector, and implementing agencies; and planning agency capabilities. State, regional and local examples.
- ** 5601, 5602 PLANNING THEORY SEMINAR (4 cr per qtr; prereq #)
Philosophical and theoretical aspects of the relationship of knowledge to public action and planning. Design methodology.
- ** 5661 ISSUES IN AGING (4 cr)
Intensive reading and class presentation on policy - relevant findings of gerontological research. Discussion will focus on current and potential approaches of and constraints on decision-makers, bureaucrats, and practitioners. Existing legislation and programs designed for older Americans will also be examined.
- ** 5691 PROFESSIONAL SERVICES AND PUBLIC POLICY (4 cr)
Goals, operation and impacts of service organizations compared and contrasted; general patterns and critical issues; incentives and disincentives in organizational or bureaucratic settings; role of professionalism; the experience of clients. Fieldwork.

- ** 8121 POLICY PROCESS II (3 cr; prereq #)
Substantive evaluation of proposed policies and their alternatives; strategies used by public interest groups dealing with policy proposals, projecting future impacts; relative roles of environmental economic, and other analyses in assessing alternative policies. Class participants will be expected to review a draft environmental impact statement during the quarter.
- ** 8201 POLICY ANALYSIS I (3 cr; prereq econ 3101 or #)
Microeconomic analysis of public policy in political and social context. Cost-effectiveness and cost-benefit analysis and their role in the process of policy making.
- ** 8202 POLICY ANALYSIS II (3 cr; prereq #)
Empirical analysis in the evaluation of public policy alternatives, application of the concepts of the nature of causal relationships and behavioral theory to the problems of informing decision making in the public sector; basic econometrics and design of experiments, review and evaluation of existing empirical policy analyses.
- ** 8206 POLICY ANALYSIS III (3 cr; prereq #)
Varieties of quantitative methods for use in policy analysis, formulation and evaluation. Attention is given to alternative frameworks for understanding policy, not only in terms of what is commonly called policy-making (and looked at from the point of view of policy-makers), but also in terms of the experience of policy by ordinary people. Topics include measurement, experimental design, survey research, evaluation research, and fieldwork.
- ** 8251, 8252, 8253 PUBLIC AFFAIRS WORKSHOP (cr ar; prereq #)
Fall, Winter, Spring. Course, seminar, and individual research sequence on select policy areas. Policy areas differ each year.
- ** 8321 INTERGOVERNMENTAL ADMINISTRATIVE RELATIONS (3 cr; prereq #)
Seminar, examination of the evolution of intergovernmental relations in the United States and of special administrative and fiscal problems and issues--with particular attention to the fields of housing, urban development, health, education, and welfare.
- ** 8511 LAW AND URBAN AFFAIRS (3 cr)
Selected concepts, procedures, and other aspects of local government law of particular concern to local administrators and others interested in the conduct of urban affairs.
- ** 8521 DEVELOPMENT MANAGEMENT SYSTEMS (3 cr)
Examination of integrated systems of controls and incentives to manage land development at state, metropolitan, and local government levels. Includes traditional planning and land use devices, tax and fee techniques, environmental regulations and innovative controls.

- * 8525, 8526, 8527 SEMINAR: URBAN PUBLIC POLICY (3 cr per qtr; prereq #)
Examination of the processes whereby governments formulate, implement, and evaluate programs designed to deal with major social and economic problems, with special reference to the organization and financing of state and local governments in the fields of welfare, education, planning and zoning, law enforcement, housing, urban renewal, and pollution control.
- *** 8531 PLANNING IN THE POSTINDUSTRIAL SOCIETY (3 cr; prereq #)
Design and analysis of public policies and plans when economy may not be a useful model. Advanced capitalist society. Policies involving ethical issues, matters of race, sex, and life and death. Ultimates and absolutes in making decisions.
- *** 8540 SEMINAR: LAND USE PLANNING (3 cr; § Geog 8340; prereq #)
Spatial analysis of housing submarkets within metropolitan settlement fields. Geographical analysis of the dynamics of housing demand and supply. Special emphasis on patterns of intra-urban migration. Seminar runs two quarters; winter-spring.
- ** 8601, 8602, 8603 ISSUES IN AGING (3 cr per qtr; prereq administrators in the area of aging or #)
Intensive reading and discussion on issues related to being old in America and public policy regarding the aged; includes social science research findings and analyses of current program. Interdisciplinary; projects possible.
- ** 8606, 8610, 8620, 8630 SEMINAR: HUMAN RESOURCE PUBLIC POLICY (3 cr per qtr; prereq #)
Analysis and discussion of major issues in various areas of human resources public policy, including assessment of effectiveness of existing programs, consideration of policy alternatives and analysis of their consequences.




