NCA Recommends Accreditation for UMC

The North Central Accreditation team recommended continued accreditation as a baccalaureate institution for the University of Minnesota, Crookston (UMC). The next comprehensive visit is scheduled for the years 2000-2001.


"Receiving continued accreditation as a baccalaureate institution is extremely important to UMC, and the team recommendations will improve the college's programs and services," said UMC Chancellor Donald Sargeant.

This is the first step in the review process. These recommendations go to a panel or reader and finally to the North Central Association of Colleges and Schools Commission for action.

The team noted several of UMC's strengths, including: the understanding and endorsement of UMC's mission by the faculty, staff and community; a long range plan which includes measurement for success; dedicated and hard working faculty and staff; positive attitude to technology; academic assistance for under-prepared students; collaboration and articulation with other institutions and industry; and administration and faculty who assess student outcomes.

Some of the team's recommendations include: need for a financial audit every two years; new baccalaureate program evaluation; money for supplies and equipment; and lack of reserve funds.

IBM Gives \$50,000 to UMC





UMC Accepted Into NDCAC

UMC has been accepted into the North Dakota Collegiate Athletic Conference (NDCAC). This unprecedented occasion marks the first time a Minnesota team has been accepted in the North Dakota Conference.


Acceptance into the North Dakota Conference provides UMC with the ability to develop a competitive schedule, which is almost impossible without conference affiliation. It also provides an avenue of post-season competition, according to Marv Bachmeier, UMC athletic director.

Colleges included in the conference are Mayville State, Valley City State, Minot State, Dickinson State, Jamestown College and Mary College.





Chancellor's Comments

We're into spring quarter, and it won't be long till another class graduates. For 90 years that has been occurring here on campus. This class will remember many changes that occurred during their UMC years. Most likely the provision of notebook computers to all students and the implementation of baccalaureate degrees will be at the top of the memories. This year moving to an intercollegiate athletic schedule with four-year colleges will be added to that list.

Our enrollment for the year has been up slightly from last year, and new student admissions for next year are slightly ahead of last year at this early stage. As I indicated in the last AGGIE we are going through the approval process to add new baccalaureate degrees. Two -- early childhood program management and

health management -- have already been approved, and three -- agriculture aviation, equine management and information management systems -- should be approved by June. This will broaden the curriculum and further increase enrollment.


We are in the midst of our planning and budgeting cycle for next year. Our focus is on increasing enrollment and activities which improve teaching and learning. The outcome of the legislative session is extremely important in terms of being able to continue the progress of converting UMC into an exemplary polytechnic college. So be sure to visit with your legislators and the Governor about the importance of the University of Minnesota's budget to the State.

The North Central Accreditation team, in late February, recommended continued accreditation as a baccalaureate institution for UMC. This is a very positive step for UMC. The next comprehensive visit is scheduled for the years 2000-2001.

It was a warmer winter, and it seemed to help things to run smoother here at UMC. Hope it was the same for you.

UMC Receives Approval For New Baccalaureate Degree Programs



UMC received approval to offer bachelor of science degrees in early childhood program management and in health management. The early childhood program is offered with pre-kindergarten teacher licensure, in cooperation with Bemidji State University (BSU).

The approval was granted by the Minnesota Higher Education Coordinating Board and the University of Minnesota Board of Regents.

Early Childhood Program Management

The first classes in this partnership degree began winter quarter. UMC students receive all courses on-site, either through regular class offerings or via interactive television courses originating at BSU. While the degree is the result of the shared program, the actual bachelor of science degree is granted by the institution of residence. Students enrolled at UMC receive their degrees from the University of Minnesota, and students at BSU receive their degrees from that institution.

The program courses originate at UMC, including general education courses, early childhood education core, and program management. All of the pre-

kindergarten licensure requirements originate at BSU.

Health Management

The health management program had previously been approved only as a minor under the bachelor of science degree program in applied management.

The difference between the minor and the major is the program focus and the depth of coursework which is specific to the health care environment. Students still take a considerable number of business courses, but there are more courses geared to health needs to better prepare students for specific needs of health care employers.

Three other programs are moving through the review and approval process. Plans are to have the following programs in place as baccalaureate degrees by the fall of 1995:

- ag aviation
- equine science
- information management systems





UMC Building Receives Architects Award

The Teaching and Outreach Center at the University of Minnesota, Crookston (UMC) received a national award for architectural excellence from the American Institute of Architects (AIA).

Architects for the building were Thorbeck Architects, Ltd., Minneapolis, Minnesota, Duane Thorbeck, AIA. University of Minnesota Facilities Management personnel working with the project were Linda McCracken-Hunt, AIA, and Charles K. Koncker, AIA.

The building was one of 10 (out of over 100) to receive the Honor Award. The award program serves as a tribute to architectural excellence. In order to encourage a high level of architecture, to recognize the clients and architects who have distinguished themselves and to inform the public of the architectural contributions, AIA Minnesota has established this Honor Awards Program.


The center provides a very modern complex so that teaching, research and outreach can be accessed by individuals literally throughout the world. It entails land and water for research, telecommunications technology for information and course sharing, facilities for teaching, housing of animals in equine and animal science, and classrooms and offices for agriculture faculty and Minnesota Extension Services.

"The center reflects the mission of the University which is not only to create new knowledge, but to be sure that this knowledge is extended into the region providing skilled graduates, continuing education opportunities for businesses and individuals, and access to world-wide information resources. The center enables UMC to better serve individuals and special-interest groups on and off campus in a sparsely populated area," said chancellor Donald Sargeant.

Cooperative Solutions Mediation Center Opens at UMC

Cooperative Solutions Mediation Center - Northwest Minnesota opened at UMC in November. The Center is coordinated by Marilyn Grave, UMC's early childhood program director.

Cooperative Solution, Inc. is a nonprofit corporation organized to provide mediation and other dispute resolution services to the public as the first option before seeking relief in the traditional court process. The board of directors operates on the philosophy that the use of mediation and other dispute resolution services best serves the public and creates more appropriate outcomes for those involved, at less cost and emotional trauma than the traditional adversarial process.



The Fifth Annual UMC/NWSA/ Community Golf Classic

Registration costs for the tournament will be \$50.00 per golfer. These fees will cover green fees, participation gifts, dinner, prizes and a contribution to the UMC Scholarship Fund or Program Development Fund.

Participation will be limited to the first 90 golfers who pay their registration fees. Fees must be paid by July 7.

The Golf Social is scheduled for 4:30 p.m. with the Golf Award Dinner at 5:30 p.m. at the Minakwa Country Club.


