Getting in Gear

Every morning, at 7 a.m., Myrtle Hanson Marti '38 is on her way to train. Twice a week she attends a total body workout class, and the other mornings she runs three or four miles at a local gym.

Myrtle has competed and placed in the Twin Cities 5 K (3.1 miles) marathon, the Melpomene, and Anoka Halloween races and is a Minnesota certified runner. Often she is put into a class of younger runners because of the absence of competition in her age group. In a 1996 Mounds View race, she ran alongside her granddaughter and five of her great-grandchildren. Some of the races are for charitable causes such as the Twin Cities Multiple Sclerosis 15 mile walk where she received \$700 in pledges. Another year she competed in the 3M Moonlight race.

Her success is even more remarkable when you discover she didn't start this hobby until 1974. She has won numerous prizes, but when asked why she participates, she says, "I run because I enjoy it."

The teachers at the Northwest School tried to bring out potential

in all of the students. Myrtle says they told us to "Be yourself. Be all that you can be."

Myrtle Hanson Marti left her Twin Valley home to attend the University of Minnesota where she majored in home economics. When WWII broke out, she immediately found a position with the Army Ammunition Plant at New Brighton.

In 1943 she married George Marti, a chemist with Harvest States. They made their home in St. Paul, and raised four daughters.

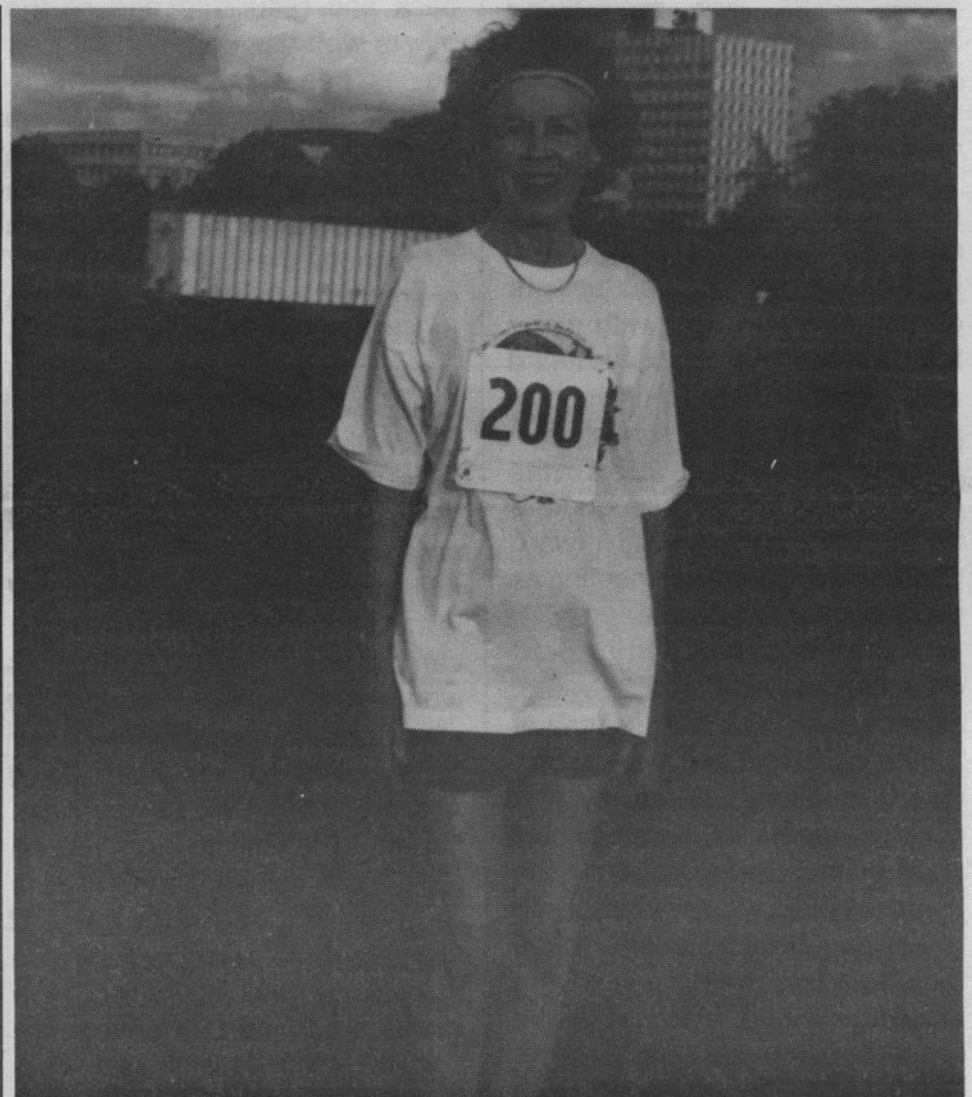
For years Myrtle was busy with her children - Girl Scouts, Sunday School, and PTA. Over the years she helped with a lot of church dinners and gave many gifts of food.

In 1975 Myrtle began work at Land O'Lakes in their analytical laboratories, analyzing all the food the company made.

Making Norwegian "kranse kakke" is also one of Myrtle's specialties. One year she made 10 cakes for Christmas - all with 18 tiers and decorated with Norwegian flags and golf leaf. Another year she baked 22 Black Forrest chocolate tortes for a catered party. She also brings her specialties to neighbors, churches, family and friends.

ment and devastation that takes place during a crisis such as we've just witnessed. However, it's also very uplifting to watch the resilience of those who suffered the most, rally and rebuild.

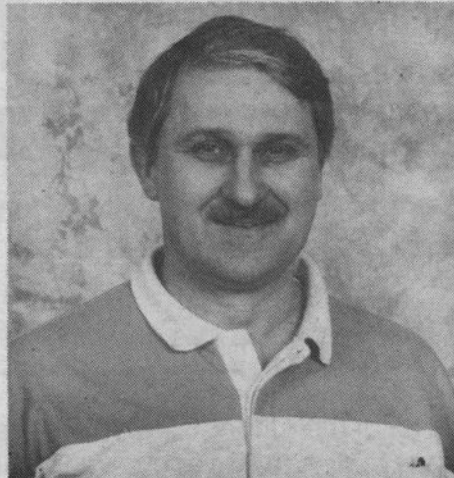

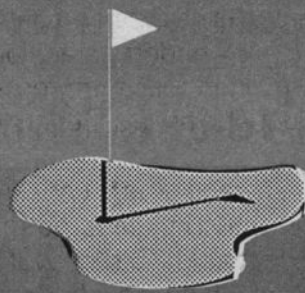

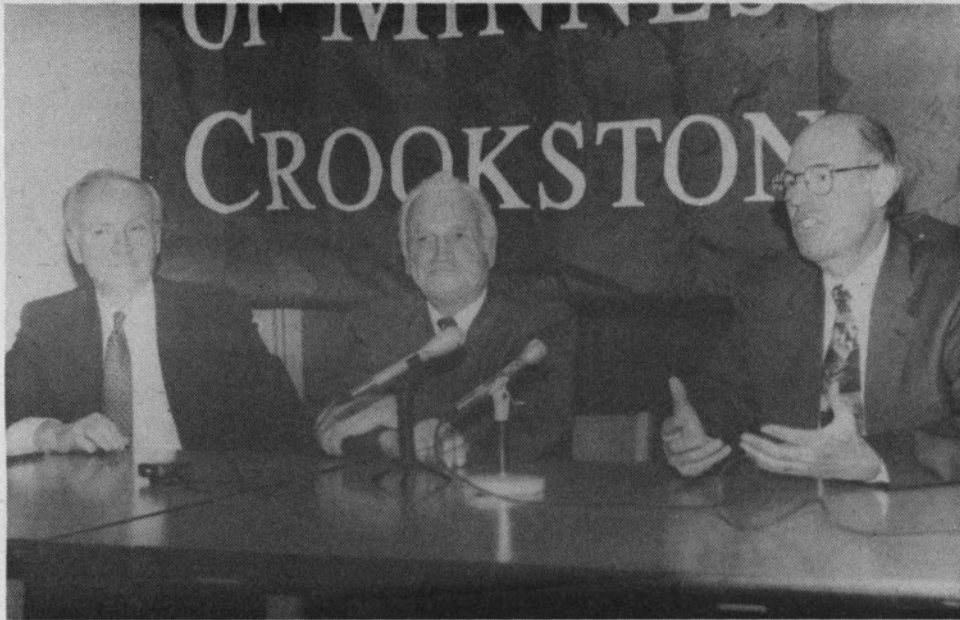

President Hasselmo Says UMC is Innovator

There was official business for Nils Hasselmo to attend to this Spring at the University of Minnesota, Crookston. He announced a K-12 technology partnership grant at a press conference. After a Swedish luncheon, there were radio interviews, followed by education forums. The evening concluded with a social and dinner.

Not diminishing the importance of any of those events, the soon-to-retire president of the University of Minnesota was also on an unofficial farewell tour, despite the fact that he will return to UMC one more time before stepping down, at commencement.

"I just came to see if you had enough snow," he joked. "And I have concluded that you do."

Flanked on one side by retiring regent and UMC founder Stan Sahlstrom and UMC Chancellor Don Sargeant on the other, Hasselmo reflected on his eight years as head of the university, and the bright outlook that has replaced what was once an uncertain future at UMC.

"UMC has been an innovator in many respects, and I'm especially pleased to see that," he said. "Crookston has led the way, you carved out your own unique style."

He was referring to the move three years ago to put a laptop computer in each student's hand, and the decision to convert to a four-year institution.

As a result, the campus has received international attention from other colleges and universities trying to duplicate UMC's blueprint of success. It's a turnaround that can be attributed to people like Sahlstrom and Sargeant, Hasselmo said, people not afraid to put their destinies in their own hands.

"That's been the most rewarding part for me in my eight years," Hasselmo said. "I've connected with so many wonderful people, I've seen many great partnerships develop between the university and the people."

The U of M's 150-year history as the land grant university in Minnesota has rubbed off on Hasselmo, and he's proud to have been a part of it. "It's such a wonderful tradition," he said. "I'm enormously impressed and grateful just to have experienced it."

If that rich tradition is to continue, state funding must increase, he said. In addition to that, UMC's innovative spirit must rub off on the other campuses.

"It's important that each campus have a different profile," he said. "We didn't have anything like this before, but we needed it. Crookston did it."

Mark Yudof, the incoming U of M president, will officially take over on July 1.

University Announces K-12 Technology Partnership Grant

Using technology to improve K-12 education in Northwest Minnesota is the goal of a new University of Minnesota project announced by President Nils Hasselmo during his recent visit to Crookston

The University's College of Education and Human Development in Minneapolis

and the Crookston Campus will partner to design and deliver education programs for K-12 teachers. Emphasis will be on using computer technology and the Internet to improve teaching and learning of core subjects including social studies,

reading and math.

Six schools have agreed to serve as pilot sites for the project and other

schools are welcome to join. Participating schools are Bagley, Crookston Public, Crookston Cathedral, Fertile-Beltrami, Fisher and Mahnomen.

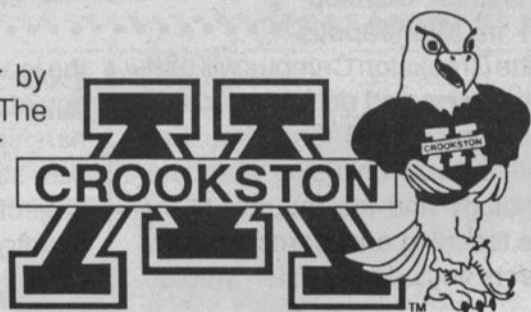
Golden Eagle Calendar

NWSA Heritage Fund Annual Drive

Our goal this year is to raise \$21,000. Last year 572 alumni contributed \$20,090. Our target is to increase the number of alumni contributors by 53 to a total of 625. Put another way, in order to reach our goal 625 alumni contributors would have to make an average gift of \$33.60.

Prior to starting the phonathon a total of \$13,674 was received from 409 NWSA alumni or an average gift of \$33.43. During the phonathon 315 NWSA graduates were contacted and an additional \$3,750 was pledged to the Heritage Fund. The pledge total was committed by 122 of the 315 alumni members contacted. To date we have a grand total of \$17,424 toward our \$21,000 goal contributed by 531 alums. This figures out to an average gift of \$32.81. If an additional 94 members (531 plus

94 would equal our goal of 625 contributors) would contribute the average gift to date, we would raise an additional \$3,084 and would be within \$492 of our \$21,000 goal.

Is it achievable? We certainly think that it is possible, when you consider the fact that during the phonathon 115 alumni said they would be sending a donation, but were not ready on the evening called to commit to an exact amount. If all 115 do send in a gift, and if the pledges sent continue to average \$32.81, we would exceed our goal of \$21,000. It should also be pointed out that during the phonathon, we made the decision not to contact alumni in the flood affected areas. To date, a number of people from flooded communities have sent in their pledges.

We thank each one of you for your support.

Teambackers 1997-98 Membership and Fund Drive Plan is Established

The Teambacker membership and athletic scholarship fund drive for the 1997-98 academic year began in May. It is intended that the majority of contacts will be completed by the end of June.

"By adopting these timelines we anticipate most membership gifts and pledges will be made by June 30. This will provide us with a better handle on the dollars that will be available for athletic scholarships in the fall of 1997," said Ed Odland, Teambacker President.

The Annual Drive format is similar to the one used last year. Ed Odland will chair the campaign and coaches Scott Oliver and Gary Senske will be team coordinators.

Plans are to set up 10-12 teams. Each team has two co-captains, a UMC coach, and approximately five or six players. Establishment of the

teams will be completed prior to the Teambacker Fun Night which is scheduled for May 9, 1997.

Membership for 1996-97 reached 380 which was just 20 short of our goal of 400. The dollars raised during the Annual Drive for 1996-97 athletic programs and scholarship was \$37,886.

Hopefully, during the Spring '97 Annual Drive, we will grow to more than 450 members and generate approximately \$50,000 for programs and scholarships beginning in the Fall of 1997.
