
Memories from the 1997 Reunion



Curt Almlie has been appointed director of Institutional Relations. He replaces Allan Larson who served in the

role for nine years before retiring the end of 1997. Curt's primary responsibilities will be in marketing UMC. He will also lead, coordinate, evaluate and participate in alumni relations, media and governmental relations, University relations, development, community relations, advertising, and promoting campus programs and activities.

Most recently Curt was the director of the Fargo ND Business Improvement District. He has been employed with the North Dakota State University Extension Service as development director of the North Dakota 4-H Foundation and as executive director of Mayville State University Alumni Foundation.

He served in the North Dakota State

Legislature from 1987-89 where he was on both the House Transportation Committee and the House Education Committee, and continued his interest as a registered lobbyist in the 1989 session. He also worked at Mayville State University as business administration instructor and assistant football coach.

Curt coordinated UMC's marketing program at UMC for a short time in 1995-96, when he was instrumental in moving UMC onto the World Wide Web.

Curt has a master of science degree from the University of North Dakota, a bachelor of science from Mayville State University and has taken postgraduate work at North Dakota State University.



From the Development Director

Presidents Club Changes

The University of Minnesota Foundation is making a number of changes in the Presidents Club on July 1, 1998. The Presidents Club as we've known it was established in 1963. It is the premier lifetime giving recognition society for University donors. It honors the leaders who have supported the University throughout the years, as well as those who have guided the University to prominence. Traditionally, a gift of \$10,000 contributed at a minimum of \$1000 annually for 10 years earned Presidents Club recognition.

On July 1, 1998, the Presidents Club will become the overall umbrella for all

of the University's major gift clubs. The reorganized structure is shown in the following table:

PRESIDENTS CLUB

for a lifetime of giving

Builders Society	Gifts of \$1 million or more
Regents Society	Gifts of \$500,000 - \$999,999
Trustees Society	Gifts of \$100,000 - \$499,999
Chancellors Society	Gifts of \$50,000 - \$99,999
Founders Society	Gifts of \$25,000 - \$49,999
Heritage Society	Deferred Gifts (revocable)

In addition to updating the Presidents Club, a new giving recognition program will be introduced on July 1, 1998, called the "Maroon & Gold Club". This club will recognize those special donors who are not Presidents Club members but who extend their generosity to the University every year. This program is intended to encourage annual giving to the University, its colleges and programs. Membership is only for the year in which the gift is made and the structure is illustrated in the following table:

MAROON & GOLD CLUB

for annually supporting your University

Gold Level	Annual gift of \$2,500 - \$24,999
Maroon Level	Annual gift of \$1,000 - \$2,499

One of my first questions was why are these changes being made? The answer is that the Presidents Club has

not been updated since 1963 when it was created. In fact, the present value of a \$10,000 gift in 1963 is equivalent to \$56,700 today. Another reason would be that the updates bring the University more in line with its Big 10 peers, all of which have made similar changes in recent years.

Having said all this, I would be remiss if I didn't let you know that there's still time to join the Presidents Club and become a charter member before the structure and increase changes go into effect July 1, 1998. Pledges of \$1,000 per year for up to 10 years may be made for membership, provided we receive your first \$1,000 check by June 30, 1998. Also, during this window of opportunity, you will receive full credit for you life to date giving. If for example, you have given the University (that includes all colleges and programs) \$4,000 life to date, you can join the Presidents Club by making a \$1,000 gift before July 1, 1998 and annual installments during each of the next five years. All current and incoming members (those joining prior to the cutoff 6-30-98) will be "grandfathered" into the new system and their memberships will not be affected.





NWSA Faculty Member Establishes Endowment for UMC

Meeting twice a week during the late 30's and early 40's, the band under the direction of Ben Bakkegard, became an important part of campus life and activities. Over those first few years the band grew to nearly 60 players, holding small group practices every day. The group appeared at all football and basketball games, as well as for many special concerts.

Besides directing the band, Dr. Bakkegard also taught English and was adviser for the class of 1942, as juniors.

It was during his years at the NWSA that he met Ardelle Hamlett, who later became his wife. The Bakkegard's returned to the campus for the 50th anniversary of the class of 1942.

Ben served in the Army Amphibian Engineers, Second Brigade from 1942 to 1945. It's a touching memory for Ben to realize that eight of his close NWSA friends from the Senior Hall were killed during that war. Their names are on the memorial at the entrance to the UMC campus.

He returned to teaching music at several universities, including California State University, where taught from 1958 until his retirement in 1980.

Ardelle passed away a year ago July, and Ben continues to live in Fresno, traveling and visiting his two children. He sings

in the choir, volunteers at the police department and enjoys woodworking and gardening.

Following Ardelle's death last July, Ben set up a remembrance to her with the **Ardelle Hamlett Bakkegard Endowed Scholarship** at the University's Crookston campus. Recipients of the scholarship should demonstrate high academic potential, strong leadership and community involvement. Ben will be recognized as a new President's Club member in the near future.

The eighth annual UMC Teambackers/NWSA/Community Golf Classic will be held this summer on Saturday, July 18. Tournament sponsors are being sought with proceeds going to the support of the UMC Scholarship Programs. We have the potential of raising over \$5,000 in net income from the tournament. The best part of all is that the tournament offers a super opportunity for a great deal of enjoyment.

All entrants of the tournament receive a token gift to signify their participation. A Hole in One Contest provides a chance to win a new car. In addition, a golf clinic will be held just prior to the beginning of the tournament for those who are interested in helping improve their game.

The tournament will utilize a Texas Scramble format with five golfers on each team. Golfers may set up their own teams, but must use the following criteria:

2. Not more than two members of the team can have 18 hole handicaps of 10 or less.

Individuals who wish to play in the tournament, but are not included in one of the preestablished teams, will be assigned to teams made up by the Golf Committee. Both men and women are invited to participate. If you do not have a handicap, one will be established for you. Registration will begin at 8:30 a.m. The golf clinic will be held at 10:00 a.m. Tournament orientation will start at 10:45 a.m. with the competition to begin at 11:00 a.m. with a shotgun start. Registration cost remains at \$60 per golfer. Included in fee are the green fees, tokens, prizes, old fashioned picnic, and contribution to Scholarship Fund. The first 90 golfers who pay their registration fees will be eligible to play. Registration fees must be paid by July 10, 1998.

Following the completion of the tournament, a social and picnic will be held and awards will be presented to the winning team, longest drive, closest to the pin, longest putt, etc. As of this date, we are hoping that the new clubhouse at the Minakwa Golf Country Club will be ready for use. 
The public is welcome to attend the commencement exercises and the reception in Brown Dining Room following the ceremonies.


