2. Adapting the study guide and new textbook with a minimum of revision of the syllabus will be paid for at a maximum of \$37.50 for a 16-lesson course, \$62.50 for a 27-lesson course with courses with other than 16 or 27 assignments to be prorated on a similar basis.
3. Revising the study guide content with probable utilization of a new textbook will be paid for at a maximum of \$50.00 for 16-lesson courses and \$87.50 for 27-lesson courses.
4. For rewriting the study guide payment will be made at a maximum of \$75.00 for 16-lesson courses, and \$125.00 for 27-lesson courses. Courses other than those with 16 or 27 lessons will be paid on a similar scale.
