R5 and R8 have been determined to be hydrologically isolated. The topographic map shows that the four wetlands are located in closed depressions in the landscape and there is no indication of a surface water connection to a water of the United States. The Dakota County Soil Survey shows that these wetlands are predominantly mapped as Kennebec Silt Loams (250) or Wadena Loams (39B), which are non-hydric soils typically found in outwash plains. However, these soil types were not confirmed during the delineation. Hydric soil indicators and low chroma colors were documented in these areas, which confirm that hydric soils are present in each of these depressional wetland basins. In addition, two intermittent drainage ways were identified in the southern portion of the review area. Based upon a review of aerial photographs, topographic maps and information submitted by AES, the two drainage ways lack a defined bed and bank, do not appear to support seasonally intermittent flow, and do not exhibit wetland characteristics. Therefore, the two drainage ways have been determined to not be waters of the United States. These water bodies do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. The water bodies were determined to not be jurisdictional under the CWA because the wetlands lacked links to interstate commerce sufficient to serve as a basis for jurisdiction.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** In the attached Wetland Map, numerous wetlands were delineated by a previous consultant; however, when Applied Ecological Services (AES) conducted their own wetland delineation in the fall of 2008 for the University of MN, they found that only four of the previously delineated basins met all three wetland criteria. In October 2008, a Technical Evaluation Panel meeting was held to review the AES wetland delineation and all the members (representatives of the City of Rosemount, Empire Township, Board of Water & Soil Resources and the Dakota County Soil & Water Conservation District) agreed that the wetland boundaries and determinations (excluding areas that lacked one or all three criteria) were accurate. Based upon this information and our review of aerial photographs, topographic maps, NWI maps and the Dakota County Soil Survey, we have determined that Wetlands R1, R4, R5 and R8 are hydrologically isolated and therefore, are not regulated under Section 404 of the Clean Water Act.
