WON IN A WALK

Kennicott Has a Majority Of 109 Votes to His Credit. Game with Michigan.

The New President

Over 400 students gathered at the Armory Saturday evening to elect the officers of the Athletic Association and the student members of the Board of Control. The contest was spirited before the ballots were cast but the results show that with one exception, all the winners had large majorities to their credit. Before the election, President Guthrie read his report which consisted of a brief survey of last year's work, and an expression of hopefulness for the future.

Nominations being called for, the names of J. A. Kennicott and O. A. Lende, both of the Law school were presented to be voted on for the office of president. Mr. Kennicott was elected by a large majority over Mr. Lende. The vote stood: Kennicott, 264; Lende, 155.

Three nominees were presented for the office of vice-president, W. C. Deering was elected, 235 votes being polled in his favor.

The position of secretary went to Paul S. Smith, who received 211 of the 402 votes cast.

There were nine candidates for student membership on the board, four from the academic, four from the medical and one from the law department. Of the academics, Frank Reed and J. V. Williams were the successful contestants; from the medics, Michael Kiefer, and from the laws, Edward Freeman. Mr. Reed holds office for two years; the other student members for one year.

For the office of president, a better man could hardly have been chosen.

CHICAGO'S VERSION

Think That They Won The Debate But Are Willing To Abide by Decision

Mr. Chandler, the coach of Chicago debating team in a signed article in the "University of Chicago Weekly," says several things in explaining their defeat, which, perhaps, prompted considerably more by partisan feeling and disappointment than anything else, but in closing he shows that he is still a sportsman ready to stand by the decision. He also speaks highly of his treatment while here by the students. He says:

"The decision is final. To be sure, there was an irregularity in the choosing of the judges, but it was an irregularity to which we consented. By the verdict we loyally abide. It gives us no ground for bitterness toward Minnesota, nor on sober thought, does anything else. Minnesota received the Chicago team hospitably, and gave the Chicago speakers generous applause. The Minnesota style of public speaking seems to us unsound, misleading and dangerous, but after all, it would be hypocritical as well as ungenerous to credit the men who foster it with any less sincerity than we profess for ourselves."

The "Weekly," in speaking editorially of the remarks of Mr. Chandler says:

"The sum of these remarks will be seen to be not any charge of unfairness, no allegation of college partisanship on the part of the judges, but merely a candid explanation of the reasons why we lost and why we regard the defeat as undeserved. The methods of the two teams were worlds apart, and decision was apparently made on the ground that oratory is worth more than clean-cut argument. It is a complaint more against a false method of speaking than it is against this particular decision.

"But having contested and lost, with these last remarks we consider the affair as closed, and hold by the result. Minnesota debated in her own fashion and won, we in ours and lost. These facts are inevitable. With all the good spirit in the world we accept the situation and wait for another year to meet Minnesota again, when we are ready to put the question to the test again and are confident of the result.

"In the coming contest with Michigan, Minnesota has our best wishes. Let her go in and win—if she can."

FACULTY MEETING

At the faculty meeting Saturday afternoon little was done but pass on an immense number of petitions. It was voted that students taking drill in the Junior and Senior years be allowed one semester's credit for the two years' work. The old rule granted them only one-half a credit for the same work.

The team, however, must show much improvement in the next two weeks if they are to win from Fond du Lac Feb. 1, as they will undoubtedly be our most formidable opponents on the home floor this year.

The Athletic Election
