One Billionth Record Added to WorldCat

At 2:21:34 p.m., Eastern Daylight Time on Thursday, Aug. 11, Anne Slane, a cataloger at Worthington, OH Libraries for 23 years, entered the 1 billionth holding in WorldCat for the book, *The Monkees: The day-by-day story of the '60s TV pop sensation*.

"We're just thrilled to have reached this milestone in WorldCat," said Meribah Mansfield, Director of Worthington Libraries. "I started library school in 1971, the same year WorldCat went online, so I feel like we've grown up together. I remember library school was all abuzz about this great new advance in technology. Now, whenever I see a new development in library technology, I think in terms of 'son of WorldCat' or building on the idea of sharing resources that WorldCat began."

34 years after going online, WorldCat contains more than 61 million unique catalog records representing 1 billion items in libraries. *The Bible, Mother Goose, Huckleberry Finn, and Alice's Adventures in Wonderland* are among the top 10 titles in WorldCat, and together those 10 titles represent more than 1 million items in libraries worldwide. On the other end of the spectrum, there are many unique items cataloged in WorldCat, treasures held in only one place in the world such as a Babylonian temple receipt for cattle and sheep used in temple services around 2350 B.C., or a papyrus manuscript of an edict issued by Publius Petronicus dating from 22 B.C.

MINITEX Union List of Serials Database Annual Update

The annual update of the *MULS; the MINITEX Union List of Serials* database in MnSCU-PALS is now complete. It is available through the "Additional Resources" link at the bottom of the "Select Library or Resources" page:

This year's MULS database contains 380,339 holdings attached to 166,304 bibliographic records.

MULS will remain available on WebPALS through Fiscal Year '05. Do keep in mind that this MULS holdings information is a static file, which contains MULS holding information as of Aug. 1, 2005. For the most up-to-date MULS holding information, search MULS online in OCLC -- through OCLC WorldCat.

The same MULS holdings information available through WebPALS is also available via the MnLINK Gateway at

www.mnlink.org

We encourage library staff to continue to use MULS through WorldCat or through the MULS database on WebPALS, rather than the Gateway version. See our message of Feb. 3 for more information:

Unique Use of WorldCat Collection Analysis

Earlier this year OCLC introduced a new product WorldCat Collection Analysis—an online service that enables librarians to analyze their libraries' collections, compare their collections with those of other libraries, and to do cooperative analysis within groups of libraries.

Recently, Washington University in St. Louis found an inventive way to use Collection Analysis in its preservation efforts. Its library is using this tool to compare its holdings to two of those libraries who are participating in Google's book digitization project. It hopes to identify which items it holds in common with those other libraries and which are unique to its own collection. Its plan is to digitize items from the works it alone holds.

So far, using Collection Analysis has revealed that the other libraries have 700,000 public domain works not in Washington University's collection that will be freely available through Google, 150,000 public domain works in Washington University's collection that would be freely available through Google, and 400,000 Washington University works not held by the two other libraries planning digitization.

According to one Washington University Library spokesperson, the next step is to use Collection Analysis to continue the investigation until they have identified which titles among the 400,000 no other library holds—perhaps 7,000 to 30,000 thousand. Those would be the ultimate targets of preservation and digitization.

New WebDewey and Abridged WebDewey Enhancements

WebDewey and Abridged WebDewey are updated quarterly. Both services contain the latest version of the schedules, tables, Manual, and Relative Index entries from their respective enhanced DDC databases. To view the latest enhancements, visit the following URL:

Macro of the Month: Inserting Today's Date into a 590 MARC field

This month's featured macro adds a 590 MARC field to a record and inserts today's date. Field 590 is not part of the standard MARC format, and it does not become part of the master record. Field 590 is stored in the archive record, exported records and OCLC-MARC records. Catalogers use this field for local notes (e.g., accessions information, local holdings or receipt dates).

If you want to change the date format from the following macro, just change "YYYYMMDD" to "DD/MM/YYYY" or whichever date format you prefer. You can also modify this macro to add a different MARC field to a record, such as a 949 with today's date. Simply replace "590" with "949."

Validation Changes to Connexion

OCLC made some changes over the weekend of August 20-21 that will affect all Connexion Client and Connexion Browser users. First we will provide a summary of the changes, followed by how they affect Connexion Client users, and lastly how they affect Connexion Browser users.

Summary of Validation Changes

There are now options for validation that allow you to choose a validation level when setting holdings (Update Holdings, Produce and Update Holdings, and Alternate Produce and Update Holdings) on existing bibliographic records or when exporting bibliographic (Export Record in MARC, Export Record in DC HTML, and Export in DC RDF) or authority records (Export Record in MARC). This change allows you to set holdings on records without having to edit records to resolve problems with master records.

Please Note: These options do not apply to new records being added to WorldCat or the Authority File or to existing records being replaced in WorldCat or the Authority File. In addition, validation will continue not to occur when you take a Delete Holdings action.

Three levels of validation

- No validation (None). The system does not perform any validation checks. Your holdings will be added regardless of the number of errors in the record at the time you set holdings or export.
- Basic validation (Basic). The system checks for the validity of elements, length, repeatability, type of data or codes, etc. For example, you will receive a validation error when
 - A tag, such as the 069, is not valid for input.
 - A field, such as the 043, occurs too many times.
 - A code, such as enk, is not valid in Lang.
- Full validation (Full). The system does a basic-level check along with a check of relationships between elements. For example, you will receive a validation error when:
 - Field 255 is present and the 034 subfield \$a is not.
 - DtSt (008/06) is equal to s and Date2 (008/11-14) contains a date when it should contain blanks.
 - Field 012 is present and BLvl (Leader/07) contains m when it should contain s.

Changes to Validation in **Connexion Client**

For Connexion client 1.30 and 1.40, validation will no longer occur automatically when you set holdings (Update Holdings, Produce and Update Holdings, and Alternate Produce and Update Holdings). Validation will continue not to occur on an Export action or a Delete Holdings action.

Please Note: If you want to check for errors prior to setting holdings or exporting, you **MUST** take an explicit Validate action. The ability to customize the validation level will be added to client 1.50, expected to be released in November 2005.

Changes to Validation in **Connexion Browser**

- The new option, Validation Levels, can be found in Preferences on the Cataloging and Authority Option screens. Go to the General Tab → Preferences → Cataloging Options. Scroll down to **Validation Levels**. From there you can select Basic, Full, or None for setting holdings on bibliographic records, or exporting bibliographic records. Repeat the same steps for setting Authority Record validation, except look under the General Tab → Preferences → Authority Options.
- A revised export option can be found on the Export Option screen as **Validate Exported Bibliographic and Authority Records**. Previously, you could change validation to On or Off. Now you can change validation to Full, Basic, or None when exporting bibliographic records, or

authority records. To change this, go to the General Tab → Preferences → Export Options → Validate Exported Bibliographic and Authority Records.

Please Note: The validation options for export apply only to a single bibliographic or authority record. There continues to be no validation when exporting a list of flagged bibliographic or authority records.

Tips on setting or changing validation in **Connexion Browser**

- The default is set to None for all validation options. You do not need to make any changes if you do not want validation to interfere with processing records.
- If you keep None as the setting, you can always take an explicit Validate Record action to check for errors prior to setting holdings or exporting.
- The export option for validation is available on all three screens. If it is changed on one screen and saved, it will change automatically on the other screen. For example, if you set Export Bibliographic Record in Cataloging to Full and save the settings in Cataloging, the option will change on the Export Option screen automatically.
- If you want to validate records automatically with the Update Holdings, Produce and Update Holdings, Alternate Produce and Update Holdings or Export actions, you **MUST** change the appropriate option in Preferences. If you choose Basic or Full, you must correct the errors reported before attempting to set holdings or export again.

MARC and Dublin Core

- The validation options for setting holdings and exporting apply to records viewed in both MARC and Dublin Core.

Where to Send WorldCat Record Corrections

If you find a mistake in a WorldCat record, such as spelling, you can report this type of error to OCLC for correction in one of the following ways:

- Send an email to bibchange@oclc.org.
- Use the Report Error features in either Connexion browser or client
 - In Connexion Client, go to Help → Useful Web Links → WorldCat Record Change Request
 - In Connexion Browser, display the record with the error, then go to View → Action → Report Error
- Use OCLC Quality Control Section's US Toll-Free FAX number (1-866-709-6252)

The Story Within the Book

The contract cataloging unit of MINITEX (ConCats) has embarked on another adventure: cataloging the Elmer L. and Eleanor J. Andersen personal library collection donated to the University of Minnesota Libraries. It is housed in the Special Collections and Rare Books of the Elmer L. Andersen Library. This extraordinary collection provides many clues to the values, interests, and extensive knowledge base of the late Governor. It is a treasure trove of quality publications and also a fertile ground for future research. So far, we have cataloged materials related to the following subjects: books and book collecting, publishing, traveling, politics and government, history and economics, parenting, religion, education, nature, literature, book arts, and more.

Many unwritten stories are to be found in enclosures in these books, which are related to the authors of the books themselves. One book that caught our attention had a mini-history of its own enclosed within its covers. *Mornings at 8:50*, by George F. Whicher, 1950, is a collection of "brief evocations of the past for a college audience." The college is Amherst College, where the author had been professor of English for 35 years, and the purpose of the talks was to inform the undergraduates of the history of the region, notable community members, and former faculty.

But another story, that of a friendship, can be surmised from the book's inscription and enclosures. The book began its journey dedicated "To the Pleadwells- Aloha from the Whichers,

May 1950," and contains the bookplate of a Laura Mell Pleadwell, the wife of Frank Pleadwell, a rare book and manuscript collector living in Hawaii. A handwritten letter from the author to "Dr. Frank" dated 11 Jan. 1951, contains the sentiments that some of the warm weather would be appreciated in Amherst, since there is "snow in the air." The conclusion of the mini-story is the confirmation copy of a telegram (called a radiogram from Globe Wireless) dated March 7, 1954. It is to Mrs. George Whicher, in Amherst. It states, "Our deepest sympathy, Love Lauramel[!]."

The book jacket notes that the author also taught at other schools, including the University of Minnesota. It also mentions that *National Geographic Magazine*, March 1950, "reproduced a photograph in color of Professor Whicher examining a letter by Emily Dickinson..." in the article, "Literary Landmarks of Massachusetts," p. 303.

These questions remain: Did Governor Andersen know Whicher when he was at Minnesota? Was Pleadwell, fellow book collector/philanthropist (Dr. Frank was a donor to the Hawaii Medical Library), a mutual friend? And the bigger question: is a person's book collection a reflection of who they are? These are not questions we catalogers have time to pursue, but we hope future scholars will find many stories to tell from the study of this collection.

To sample the Elmer L. and Eleanor J. Andersen Collection, follow these steps:

- Go to the University Libraries' catalog, MnCAT

- In the "Command" search option type in the command string "wsc=tandrare" to locate items in this collection.

Check back often for new additions to the library collection. During July 2005, ConCats added over 500 records to this collection.
