- One Stop closed January 7-8 to process requests

## Graduate/professional

- Colleges that decided by December 9 are collecting student information and emailing changes to OTR

# Academic Standing / Financial Aid Disbursement

- Academic Standing
  - Calculations running **January 1-11**
  - S/N only query
  - [Probation review guide](#)
  - Communication plan with students
- Fall 2020 Satisfactory Academic Progress (SAP) will run **January 11** for undergraduates
- Spring 2021 financial aid will disburse **January 13**



# Grade Bracketing / Degree Posting

- Grade bracketing starting **January 4**

- UGRD degree clearances due **January 19**



# Transcript Memo

Similar to spring 2020, a transcript memo will be added to reflect grading basis policy changes.

- Same as previous memo: ***“Due to the COVID-19 pandemic, Satisfactory/Not Satisfactory grading permitted for many classes and degree requirements.”***
  - Summer 2020: TC/RO UGRD and GRAD
  - Fall 2020: TC/RO UGRD
  - Spring 2021: TC/RO UGRD
