## SEAT SALE OPEN WEDNESDAY FOR MASQUERS' BIG PLAY

Exchange Sale To Last Until Friday—Only One Performance To Be Given.

Replete with special scenery and costumes, the annual spring Shakesperian production will, in all probability, excell any performance ever presented by the Dramatic club at Minnesota.

"The Merchant of Venice" is especially well suited to the members of the cast, Robert Wilson's portrayal of Shylock being considered one of the best interpretations ever presented on the campus by an amateur. With Enza Zellar, as Portia, assisted by Frances Works as Nerrissa and Myrl Wheeler as Jessica, the success of the performance is justifiably predicted.

In all probability a special performance will be given at the May Fete, besides the one performance to be given at the Princess theater May second. It is not asured as yet, however, as Mr. Wilson may have to be at the summer forestry camp at Lake Itasca. If a special change can be made in the faculty ruling so that Mr. Wilson will be allowed to participate in the May Fete, the extra performance will be given, otherwise the only presentation will be given next Tuesday evening.

Exchange tickets will be placed on sale in the rotunda of the Library both Wednesday and Thursday mornings and can also be procured from any member of the Masquers. Tickets will sell at \$1.00, 75c and 50c, and can be exchanged at the Northwestern Book store or at the Cable Piano company, Eighth and Nicollet, on and after April twenty-eighth. All tickets will be placed on sale at the above named places, Friday morning. Gallery tickets will not be reserved and will be sold at the ticket office of the theater only on the evening of the performance.

Fraternities, sororities and other organizations wishing to make special reservations for boxes or tiers of seats can do so by notifying Hanford Cox, box 410, before Friday morning, as all tickets will be placed on sale on that day. At present an unusually large number of societies have signified their intentions of coming to the performance in a body and from present indications a large number of Twin City society people are also planning to attend the performance and make the evening a social event.

Col. Whittier and Major Earl Bill are the delegates from Minnesota and will have charge of the convention.

Washington Yale, an alumnus of Minnesota, is colonel of the national organization and will preside at all the meetings. On Friday afternoon there will be a preliminary business meeting and in the evening a dance at Mrs. Nobles hall has been arranged for. There will be a business session on Saturday morning and in the afternoon the members will be shown about the Twin Cities in autos.

The convention closes with the annual banquet, which will be held at the Hotel Radisson on Saturday evening. "Several new chapters from various colleges have been petitioned for and every year a greater interest seems to be aroused among the ever increasing chapters of the Scabbard and Blade," said Hanford Cox in speaking of the convention.

## JUNIORS TO BE ELECTED TO BOARD OF GOVERNORS

Twenty-Three Candidates For Eleven Offices—Present Members Conduct Election.

Election of the next board of governors of the Men's Union will be held tomorrow, between the hours of nine and three. At a meeting of the present board last Wednesday it was voted that two men from each department have charge of the election. For the academic division, Henry Bruchholz and Frederick Ware were chosen and the election will be held in the rotunda of the Library; for the engineering, Marvin C. Barnum and Joe B. Perry, the election being held in the Mechanic Arts building; for the law section, Harold Hull and Alonzo E. Parker, the place of election being the Law building; for the Medical section; Harry Emmert and Frank J. Harth and the place of election, Millard hall.

The board is particularly anxious that every man in the university cast his vote and that an effort be made to conduct a clean election. "The purpose of the association is to promote the best interests and welfare of the university and comradeship among its members and to erect and maintain a suitable club house for such purpose."

The candidates for election are as follows: Academic section (3 to be chosen); Earle C. Bailie, John Egan, George Gamble, and Walter West; Frank Peck and Wm. F. Hagerman from the Agricultural school.

The Medical section (3 to be chosen), W. G. Workman, C. B. Drake, medicine; C. M. Riley and J. H. Ostedt, pharmacy; G. E. Abrahamson, and K. L. Rice, dentistry.

Engineering section (3 to be chosen) John Lewis and Roswell Prouty, mines; Robert Brooks and Harold West, E. E.; Eugene Crane, M. E.; Dale McEnary, C. E.

Law section (2 to be chosen), Kenneth Cant, Hugh L. Lothrop, J. E. Kain, Charles Horn and Arthur Barke.

## MAGAZINE CONSTITUTION TO BE SUBMITTED SATURDAY

Mag. Board And Press Committee Submit It To Subscribers For Ratification.

The Minnesota Magazine board and the press committee of the University council have agreed upon a constitution for the Magazine. It will be submitted for ratification to all paid-up subscribers on next Saturday morning from nine till one o'clock. A four-sevenths vote in favor of it on the part of all those voting then will ratify it.

The constitution provides for an editorial board composed of twelve students at most, and one faculty man who is appointed by the press committee subject to the board's approval. The student members are elected by the board from the three upper-classes.

The constitution will appear in full in tomorrow's Daily.

## FACULTY REPRESENTATION AROUSES MUCH OPPOSITION

Idea Of Faculty Members For Gopher Board Meets Strong Foesmen Council Opposed—Opinion.

The idea of faculty representation on the 1913 Gopher Board is arousing much opposition wherever it is discussed in college circles.

It is conceded that the present organization is far from being efficient and various plans have been suggested to remedy the situation. One plan is that of having a faculty representative on the board.

Just what will be the powers and duties of this individual, no one seems to know. Michigan is the only other college of any consequence in the United States where such conditions exist.

Yesterday the student council drew up the following resolution in regard to the Gopher constitution: "Be it resolved, that the student council opposes faculty supervision of student activities where the responsibility of carrying on such work can be adequately borne by the students.

"In the case of the Gopher, the council believes that the present finance committee will have sufficient opportunity to check and supervise the accounts of said organization, and is therefore opposed to faculty interference."

The following, are the opinions of some prominent college people on this question:

Earle Bailie, managing editor of the 1912 Gopher: "I am very much opposed to faculty representation on the Gopher. The Gopher is a class book and should represent the class. I would advise the sophomore class not to publish a Gopher next year if they are forced to have a faculty member on the board, as I do not believe a Gopher up to Minnesota standard could be brought out under such unfavorable conditions."

Hanford Cox, editor in chief of the 1911 Gopher: "Faculty representation on the Gopher board will, I think, reduce the scope of the book and tend to make it a mere record of events as is the Yale Potpourri and the Williams Annual. The most interesting part of the book in the past has been the so-called feature department. Experience at other colleges has shown that faculty supervision tends to eliminate this. College students are not of the high school age and surely they have proved themselves to have some little discretion."

Henry Bruchholz, managing editor of the Magazine: "The proposal to put a faculty representative on the editorial board of the Gopher should be defeated on several grounds: first, it would make impossible the publication of junior annuals in the future; secondly, it is an unwarranted encroachment upon a legitimate student enterprise; and lastly, the resistance to it on the part of the present sophomores who will be expected to publish the annual next year, and on the part of members of past boards who have had experience in the getting out of Gophers, is sufficient evidence of its undesirability."

Elizabeth Ware, president of the Woman's League and member of the Magazine Board: "Since the forma-

The question before the sophomore class in regard to their new Gopher constitution seems to have boiled down for the present to the single point of Faculty Representation on the Board. Our views on any such movement have already been expressed, but the present agitation stirs us to further comment.

Those who advocate the movement ask us if any harm would be done. We would answer, "Decidedly." We would say that the function of the Board has been one exclusively for students to perform; that any faculty interference or even representation would vitally change the spirit in which the Gopher is regarded by both the Board and the students. We could say that it would go a long way towards destroying about the only tradition that we have.

The sophomores are completing a constitution which will undoubtedly remedy many of the evils which have always shaded the brilliance of the book. They are trying to make the Board not only representative but more efficient. They are to have a system which has been tried and proved to be adequate. To those who have seen the previous books in the process of publication it seems as if the new plan would be an excellent improvement.

Probably the greatest evil in former years has been the lack of financial responsibility. There has been no sufficient check on the Board, and this has often led to embarrassing situations. The Board next year will be so constituted that the danger of any exploitation by the management will be practically eliminated. Besides which, the Board of Regents has a Finance Committee, expressly for the purpose of overlooking the accounts of such enterprises. So it would seem that there is little need for a faculty man for such a purpose. As far as the improvement of the contents of the book is concerned, the students have an idea that any such improvement made by faculty representation could be dispensed with for the sake of having the Gopher a student publication.

So the Daily has come to the conclusion that any faculty representation would not only have little or no beneficial results, but it would likely work a great deal of harm. We think further, that with the sophomore class in their present state of violent opposition to the movement, it would be disastrous to next year's Gopher to put a faculty man on the Gopher Board.

tion of the regents' finance committee, as requested by the student publications, I cannot see how faculty control of the Gopher will be advantageous."

Allan McBean: "I am opposed to faculty censorship of Gopher copy. I do not think experience has shown this to be necessary."

Anne Hull, president of Student Government association: "Vagueness in the matter of the finances of the past Gopher Boards seems to be the only legitimate reason for establishing faculty representation on the board. Since the finance committee has been organized definitely to supervise financial arrangements there remains no reason for other faculty supervision. The Gopher is strictly a student annual. The students have a right to control it."

Roswell W. Prouty, mining representative to the 1912 Board: "I think that the Gopher should stay as it is at present; a strictly student affair. It is now under the supervision of the Finance Committee and in my opinion that is enough."

Phil Ray, president of the Junior class and member of this year's Board: "The Minnesota Gopher should be strictly a student enterprise and in my opinion, faculty representation on the Board would surely mean a falling off in the student interest and enthusiasm which is so essential in successfully getting out a snappy college annual. I am strongly opposed to it."

Helena Fitzsimmons, member of the present Board. "The juniors of next year might as well resign themselves to a Gopher minus everything that goes to make it a Gopher if there is to be a faculty member on the Board."

Carl Hamilton, senior forester: "University students should be credited with enough good judgment to manage their own enterprises without faculty intervention. The Gopher is a student enterprise and faculty representation is decidedly unnecessary and unwise."

Mary B. Kolars, 13: "The question is merely one of common sense. There is a well organized and thoroughly efficient committee to super-

intend the finances of the Gopher and hence any faculty member for that purpose is superfluous. In regard to the other phases of the Gopher activity, there can be no question that the book should embody student feeling rather than any other."

Dale McEnary, Engineering Representative to the present Board: "The Gopher is a student year book and as such should be gotten out by the students and by them alone. Faculty intervention would destroy many items of interest to the student public; youthful enthusiasm would be restricted and lack of originality would be clearly shown. Altogether, the faculty and students could not work together in matters of student interest."

Harold R. Taylor, ex-managing editor of the Daily: "Whenever a student publication has the proper financial supervision, and has an editorial board of sufficient discretion, the faculty has no legitimate excuse whatsoever to enforce their representation on its staff. The Gopher is a student publication, published by and for students, with proper financial supervision, and has an elective editorial board composed of competent students. Any attempt of the faculty to secure representation on it should be opposed."

George Gamble, member of the student council: "I am heartily opposed to having a faculty representative on the Gopher Board. We have effective supervision of student publications through the finance committee and I know that the student body as a whole is against editorial supervision by the faculty."

Diogenes: "Faculty representation on the Gopher is another outbreak of the childish diseases now rampant on the campus."

Plans are being formed for the construction of an aerial workshop and station at Cornell.

To Editor of Daily:—

It has been rumored about the law school, and the rumor seems to be well founded, that practically the entire faculty have united in endorsing a certain member of their number for dean. Doubtless this endorsement will have some weight with the regents when it comes to making the selection, and justly so.

However, they will do well to take into consideration the fact that the professor endorsed has had a long and intimate acquaintance with the members of the present faculty, many of whom are doubtless under obligations to him; also this, that these same professors might not wish to have an outsider put in that position because of the possibility of its resulting in a complete change of the present order of things.

Any or all of these considerations might have influenced the members of the faculty in making this endorsement.

The writer is strongly of the opinion that a large majority of the alumni, and others who keep in touch with affairs at the law school, to whom no strings are attached, would not concur in the endorsement made by the faculty. Not only that, but he knows from an intimate acquaintance with a large number of students now in the law school, that an overwhelming number of them would strongly disapprove of the professor in question being elected to the deanship.

What we want at Minnesota is a law school that we can be proud of, one that will not have to take a back seat for any law school in the west.

Aker, Minnesota's crack middle weight, although outweighed by twenty pounds would have won his event handily, but for a slight error in judgement.

In the fencing event, Eisler the first man to represent Minnesota in this sport got third place.

J. H. Nelson, a sophomore academic was elected captain of next year's team.

Several changes were made in the constitution governing intercollegiate gymnastic meets. The maximum limit of a team shall be ten instead of six and the contests hereafter will include a broad sword contest.

The meet next year will be held at Illinois.

**WOMAN'S LEAGUE ELECTION**


**Shevlin To Be Scene Of Woman's League Council Election To-Day Candidates.**
