THE PEOPLE VERSUS MALCOLM MOOS, PAUL CASHMAN AND JAMES REEVES

WE THE AFRO-AMERICAN ACTION COMMITTEE MOVING IN THE INTEREST OF ALL STUDENTS HEREBY INDICT THE UNIVERSITY OF MINNESOTA: PAUL CASHMAN, JAMES REEVES, MALCOLM MOOS, RICHARD ROE, JANE DOE, ET AL:

1. HEREBY INDICTED FOR INSTITUTIONAL RACIST PRACTICES AIDING AND ABETTING THE STATE, GEORGE SCOTT AND THE HENNEPIN COUNTY GRAND JURY IN THE POLITICALLY MOTIVATED INDICTMENTS ISSUED TO HORACE HUNTLEY, WARREN TUCKER, ROSEMARY FREEMAN, RICHARD ROE AND JANE DOE.
2. WE INDICT THE UNIVERSITY, JANE DOE, RICHARD ROE, ET AL FOR CONTINUING TO DENY BLACK, INDIAN, CHICANO, AND WHITE STUDENTS A CHANCE FOR A MEANINGFULL EDUCATIONAL EXPERIENCE.
3. WE INDICT THE UNIVERSITY OF MINNESOTA, THE CITY OF MINNEAPOLIS AND THE STATE OF MINNESOTA FOR WILLFULLY AND KNOWINGLY DENYING THE CONTRIBUTIONS OF AFRO-AMERICANS OF AMERICAS FIRST CITIZENS, THE SOUIX AND THE CHIPPEWA ET AL AND THE CHICANO AMERICAN BY EXCLUDING COURSES AND SUBJECT MATTER THAT REFLECTS CREATIVE ACTIVITY OF THESE PEOPLE.
4. WE INDICT THE UNIVERSITY OF MINNESOTA ALONG WITH THE PUBLIC SCHOOLS OF MINNESOTA ET AL FOR WILLFULLY AND KNOWINGLY CREATING A PROPAGANDA MACHINE WHICH THEY SO LABEL AS EDUCATION. WE STAND READY TO DECLARE TO THE STATE THAT THIS SAID INSTITUTION IS MERELY A FINISHING SCHOOL FOR ROBOTS I.E. NONHUMANS, MONSTERS, FREAKS, PIGS, AND THE RACIST PEOPLE WHO PLACE MATERIAL GAIN AND THE ACQUISTION OF PROPERTY ABOVE THE WELFARE OF PEOPLE.
5. WE INDICT MALCOLM MOOS, PAUL CASHMAN, AND JAMES REEVES FOR AIDING AND ABETTING THE UNIVERSITY POLICE DEPARTMENT AND WILLFULLY AND KNOWINGLY CREATING BIAS EVIDENCE IN THE FORM OF PHOTOGRAPHS WHICH SUPPOSEDLY DEPICKED WEAPONS WHICH THE SAID BLACK STUDENTS HAD TO DEFEND THEMSELVES IN THE SAID MORRILL HALL TAKEOVER.
 - A. FOR PHOTOGRAPHING A BOTTLE WHICH CONTAINED DUPLICATING FLUID WHICH SAID MACHINES IN MORRILL HALL NEED FOR MAINTENANCES. WE ACCUSE POLICE FOR DELIBERATELY INSERTING INTO SAID BOTTLE A RAG THEREBY TURNING AN EMPTY BOTTLE INTO A SAID MOLOTOV COCKTAIL WHICH SAID BLACK STUDENTS SUPPOSEDLY MADE IN THE SAID MORRILL HALL TAKEOVER ON JANUARY 14 AND 15, 1969 FOR THE SAID PURPOSE OF BURNING DOWN THE SAID BUILDING LOCATED ON THE U OF M CAMPUS. WE HEREBY SUBMIT THAT THIS INFORMATION IS FALSE, WILLFULLY AND KNOWINGLY SUBMITTING SUCH SAID INFORMATION IN ORDER TO AROUSE THE PROPERTY MATERIALISM OF THE SO CALLED LAW ABIDING CITIZENS OF THE SAID STATE OF MINNESOTA.
 - B. WE FURTHER SUBMIT THAT THE UNIVERSITY HAS WILLINGLY AND KNOWINGLY ALLOWED THE ISSUES FOR WHICH SAID HALL WAS TAKEN OVER FOR, TO BECOME OBSCURED BEHIND THE FACADE OF LAW AND ORDER.

WE DEMAND THAT THE PEOPLES JUDGE AND THE PEOPLES SHERIFF NOW CARRY OUT THEIR LEGAL RESPONSIBILITY AS REPRESENTATIVES OF THE PEOPLE AND INFORM THE SO DEFENDENTS NOW SITTING IN SCOTT HALL OCTOBER 17, 1969 THAT THEY HAVE BEEN APPOINTED A DEFENSE ATTORNEY BY THE PEOPLE TO REPRESENT THEM IN THE SAME FASHION AS OUR SISTER AND BROTHER IN THEIR SO CALLED COURT OF JUSTICE. THE COURT OF THE PEOPLE NOW BEGINS.
